1. Review Draft Meeting Minutes from April 14, 2021, Meeting. Minutes were reviewed and approved.

2. FPFP Task #21-001. -*Tabled for Future Meeting*. Follow up efforts on the use of fire testing standards not referenced in 780 CMR. Workshop on developing methodology for use by designers and officials in reviewing nonprescriptive approaches as follows:

- a. New Construction- Modifications 780 CMR 104.10,
- *b.* New Construction Alternate Materials, Design and Methods of Construction and Equipment 780CMR 104.11,
- c. Existing Buildings Modifications 780 CMR, Chapter 34104.10,

- *d.* Existing Buildings Compliance Alternatives in accordance with 780 CMR Chapter 34, Section 104.11
- 3. **FPFP Task #21-002.C9** Review of 2021 IBC Chapter 9 for the 10th Edition of 780 CMR. Review of Chapter 9 continued. The results of a Section 907 review include recommending carrying forward Mass Amendments in Sections 907.2.8.3.1, 907.2.9.1 Exception #2, to in 907.2.10, Exception to 907.2.14, and 907.5.2.2.6. Also discussed was Section 907.2.12.2 and to strike 510 of the IFC and replacing it with 918.

4. FPFP Tasks #21-002.C4, C14, C26 & C34 was tabled. Review for conflicts and recommendations on fire protection criteria in the following:

- a. 2021 IBC Chapter 4 (FPFP Task #21-002.C4)
- b. 2021 IBC fire protection provisions for exterior walls in Chapters 14 & 26 (FPFP Task #21-002.C14& C26).
