MEMORANDUM AND ORDER ON COMMISSION'S QUESTIONS OF MOOTNESS AND CONSOLIDATION

Fashionable Concepts LLC d/b/a Wine and Market appealed the December 5, 2022, and February 6, 2023, actions of the Framingham Board of License Commissioners denying their M.G.L. c. 138, § 15, all alcoholic beverages retail license renewal. The Commission scheduled a hearing for February 13, 2023, concerning the Licensee's appeal of the December 5, 2022, action of the Local Board. Prior to the date of the hearing, the Licensee filed a Motion for Judgment on the Pleadings. On February 13, 2023, the Commission heard arguments regarding said Motion and took it under advisement. In addition, the Commission raised the issues of mootness and consolidation. The hearing regarding the appeal was continued. Both the Licensee and City of Framingham were asked to submit briefs addressing the issues raised by the Commission. Said briefs were timely filed.

Pursuant to 801 CMR 1.02 (10)(a) and 801 CMR 1.02 (10)(f), the Commission hereby consolidates the Licensee's appeals of the December 5, 2022, and February 6, 2023, actions of the Framingham Board of License Commissioners denying their M.G.L. c. 138, § 15, all alcoholic beverages retail license renewal. The Commission is consolidating the appeals in order to consider all relevant evidence relating to the denial of the Licensee's 2023 renewal. The Commission will schedule the consolidated appeal in the ordinary course.
