Kenny Liquors Inc. dba Union Big Mart (the "Licensee") holds an all-alcoholic beverages license issued pursuant to M.G.L. c. 138, §15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, February 7, 2012, regarding an alleged violation of M.G.L. c. 138, §34. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Jan Kujawski's Compliance Check Field Report.

FACTS

- 2. An underage operative working with the Investigators, purchased an alcoholic beverage, a bottle of Bud Light beer, for two dollars and eighty cents (\$2.80). The underage operative was not asked for identification.
