Specifically, they requested updates to the Consumer Fact Sheet and an evaluation and prioritization of updated consumer information on the Board website. They requested that the Board consider a centralized listing of legal decisions related to complaints and disciplinary actions as well as consumer resources for families, such as the Department of Transitional Assistance ("DTA"). Janet Leombruno, the Board's consumer representative, offered to assist and the Board instructed staff to include as a recurring topic at subsequent meetings.
