Discussion:

• Policy Update – Funeral Assistant Training and Continuing Education

The Board reviewed the draft policy for approved funeral assistant training in order to determine the number of required hours in the areas of general health, ergonomics, funeral service law and ethics, as well as OSHA certification in the risk and prevention of bloodborne pathogens. The Board agreed that the policy should establish a reasonable standard for funeral assistant training carried out by the supervising Type 3 funeral director, a third-party course provider, or a combination thereof. In addition, the Board reviewed

national standards for funeral assistant training that Mr. Kelley presented to the Board. The Board agreed that third-party worksite training must be approved by the Board in order to satisfy educational criteria pursuant to 239 CMR § 3.02(4)(g) on a case-by-case basis. Further, the Board acknowledged that establishing approved third-party providers would not alter in-house training by the Type 3 funeral director or the completion of an associate's degree in mortuary science from a program meeting the requirements of the American Board of Funeral Service Education ("ABFSE").

After further discussion, Mr. Driscoll moved to assign four hours of pre-registration course credit to the aforementioned areas of Board-approved funeral assistant training. Mr. Brezniak seconded. Motion passed by a roll call vote: Mr. Phaneuf: "Yes", Mr. Driscoll: "Yes.", Mr. Brezniak: "Yes.", Mr. Gormley: "Yes.", Ms. Leombruno: "Not present".

At 11:07 a.m., Mr. Driscoll moved to adjourn the meeting. Mr. Gormley seconded the motion. Motion passed by a roll call vote: Mr. Phaneuf: "Yes", Mr. Driscoll: "Yes.", Mr. Brezniak: "Yes.", Mr. Gormley: "Yes", Ms. Leombruno: "Not Present".
