Forest Stewardship plan

Get expert forestry advice

Provides the tools and knowledge to develop a forest management plan that reduces the likelihood of the development of forestland by encouraging active forest management.

Eligibility:

- Eligible landowners encompass individuals, trusts, land trusts, clubs, LLCs, associations, leaseholders, corporate entities and municipalities.
- Project areas of 10+ acres, with at least 7 acres designated as "wooded" and the remaining acres as "eligible," that are not currently enrolled in Forest Stewardship or Chapter 61, 61A, or 61B programs.
- Landowners currently enrolled in Chapter 61A or 61B without an existing forest management/stewardship plan.
- Forest Stewardship Cost-Share Reimbursement is exclusively for new Stewardship Plans*. Recertifications and amendments to existing plans do not qualify for cost-share reimbursement. The cost-share application must be approved by DCR before work on the plan begins.

Foresters for the Birds

The bird assessment, conducted by a specialized Massachusetts Licensed Forester, becomes an integral part of your holistic approach to forest management, harmonizing with goals such as promoting forest health or enhancing recreational trails. The resulting recommendations are then seamlessly woven into your personalized Forest Stewardship Plan.

Eligibility: Landowners & Municipalities with 10 or more wooded acres that are currently enrolled in the Current Use / Forest Stewardship Program or applying for a new Forest Stewardship Plan at the same time.

Technical Assistance Cost-Share extends a cost-share opportunity, covering a greater portion of a private forester's time to assess your goals through a climate lens and meticulously review the finished plan.

COST-SHARE RATES

Acreage	Cost-share Reimbursement for NEW Stewardship Plans
10 to 36 acres	\$1,140
37 to 499 ac	\$1,140 + \$16 per every acre over 36 acres, or $1,140 + ((\text{total ac} - 36) * 16)$
Over 500 ac	\$14,622 max reimbursement* \$1,140+ \$14.00 per every acre over 36 acres, or $1,140 + ((\text{total ac} - 36) * 14)$
Over 1,000 ac	\$19,622 max reimbursement** over 1,000 acres **\$1,140+ \$12.00 per every acre over 36 acres, or $1,140 + ((\text{total ac} - 36) * 12)$

When applicable, cost-share reimbursement rates for programs like Foresters for the Birds or Climate Forestry, or when combining these programs, are provided in addition to the cost-share reimbursement for new Stewardship Plans. For instance, imagine a landowner with a 100-acre property not currently enrolled in Forest Stewardship or Chapter 61, 61A, or 61B programs, who seeks a new plan integrating both Climate Forestry and Foresters for the Birds. In this scenario, they would be eligible to receive \$1,140 plus \$16 per acre over 36 acres, totaling \$2,164, and an additional \$3,700 for Climate Forestry and Foresters for the Birds. Therefore, the total reimbursement for the landowner would amount to \$5,864.
