Conservation Assistance for Small Communities Grant FY 2021

1. GRANT OPPORTUNITY SUMMARY:

A. PROPOSALS SOUGHT FOR: Financial assistance to small municipalities (6,000 or fewer residents) to produce an Open Space and Recreation Plan (OSRP), or to complete another plan to facilitate land conservation, and/or to prepare an appraisal of land, as required to apply to the Local Acquisitions for Natural Diversity (LAND), Parkland Acquisitions and Renovations for Communities (PARC), Landscape Partnership, Conservation Partnership, or Drinking Water Supply Protection (DWSP) grant programs.

B. OVERVIEW AND GOALS: The Executive Office of Energy and Environmental Affairs (EEA) protects, conserves, and restores the natural resources of the Commonwealth. This program assists municipalities with populations below 6,000 in meeting the eligibility requirements for the EEA grant programs, which provide funding for acquisition of land for conservation and recreation. Funding will be provided to all eligible municipalities on a first-come, first-served basis.

This program is a component of the Baker Administration's goal of enhancing outdoor recreation opportunities, conserving natural resources and open space, and addressing climate change. It is part of a longstanding tradition of protecting the Commonwealth's rich natural heritage for the generations to come.

C. ELIGIBLE PROJECTS:

- 1. **An appraisal of the value of the fee simple interest or a conservation restriction (CR)** of land suitable for conservation or recreation. In order to be eligible for funding, the applicant municipality must also apply to the FY22 LAND, PARC, DWSP, or Landscape Partnership grant program to acquire the appraised property, or, a qualified 501(c)(3) non-profit may apply to the FY22 Conservation Partnership grant to acquire the appraised property if the applicant municipality will hold an interest in the subject property.
- 2. **Preparation of an Open Space and Recreation Plan (OSRP)**, including the updating of an expired plan. In order to be eligible for OSRP funding, the applicant municipality must also apply to the FY22 LAND, PARC, DWSP, or Landscape Partnership grant program, or, a qualified 501(c)(3) non-profit may apply to the FY22 Conservation Partnership grant program if the applicant municipality will hold an interest in the subject property.
- 3. **Other planning to facilitate conservation projects.** Other plans to promote conservation may be funded at EEA's discretion.
- 4. A combination of these.

See Section 2A.

D. ELIGIBLE APPLICANTS: Conservation commissions of municipalities with a 2019 estimated population of less than 6,000 people. See Section 2B. Eligible communities are listed in Attachment B.

E. APPLICATION DEADLINE: Rolling basis, no later than Friday, May 7, 2021. Funding is available on a first-come, first-served basis; applications will be accepted on a rolling basis until all allocated funds have been awarded. See Section 4.

F. FUNDING AVAILABILITY:

This grant provides an 80% reimbursement for approved project expenses in the following amounts:

Appraisal: up to \$ 3,000 OSRP: up to \$ 12,500 Other plans: up to \$ 5,000

G. BUDGET REQUIREMENT: Applicants selected to receive grant funding must show municipal expenditures for the total project cost, upon which reimbursement under this program will be based. Community Preservation Act (CPA) payments may be paired with this grant. Municipalities that use CPA funds are responsible for ensuring compliance with CPA requirements, and are encouraged to also consult the LAND, PARC, DWSP, or Landscape Partnership grant BIDs. See Section 2D.

H. TOTAL ANTICIPATED DURATION OF CONTRACT(S): The contract period will begin on the date EEA executes the contract. Contracts issued pursuant to this BID must expend costs associated with the approved project by:

Appraisals: June 30, 2021

OSRP: June 30, 2021 and/or June 30, 2022 Other plans: June 30, 2021 and/or June 30, 2022

I. REGULATIONS, STATUTES, OR AUTHORIZATION GOVERNING THIS GRANT PROGRAM:

This BID is issued according to M.G.L. c. 132A, §11 and 301 CMR 5.00, Chapter 312 of the Acts of 2008, Chapter 286 of the Acts of 2014, and Chapter 209 of the Acts of 2018. All applicants to whom grant assistance is provided to prepare an appraisal must also submit a complete and eligible application to the FY 22 LAND, PARC, DWSP, or Landscape Partnership grant program for funding to acquire the appraised property for conservation and/or recreation purposes, or an eligible 501(c)(3) non-profit partnering with the municipality may apply to the FY22 Conservation Partnership grant program to acquire the appraised property, and in which the applicant municipality commits to hold an interest in the land. All applicants to whom grant assistance is provided to prepare an OSRP must submit an eligible application to the FY22 LAND, PARC, DWSP, Landscape Partnership, or, an eligible non-profit may apply to the FY22 Conservation Partnership grant to acquire a property in which the applicant municipality commits to hold an interest in the subject property. All applicants to whom funding is provided for other conservation planning that is specific to a particular property or properties must apply to the FY22 grant round of one of the aforementioned EEA grant programs. Awarded municipalities will not be reimbursed for work done under the contract unless and until these criteria are met. Land acquired with funding assistance from any EEA grant will become protected open space under Article 97 of the Amendments to the Constitution of the Commonwealth of Massachusetts, dedicated to conservation use in accordance with M.G.L. c. 40, §8c, or recreation use in accordance with M.G.L. c. 45, §3 or 14, depending on the type of grant for which the applicant applies.

2. Performance and Contract Specifications

A. ELIGIBLE PROJECT(S)/SCOPE(S) OF WORK: EEA seeks to further the preservation of suitable open space and recreation land within the Commonwealth. Funding is offered through this grant program for several different project types; a municipality may seek funding for one or more projects. Only work conducted during the municipality's contract period (after municipality receives a signed contract back from EEA) is eligible for funding.

Project types:

1. **Real property appraisal:** Funding for appraisals required for application to the LAND, PARC, DWSP, or Landscape Partnership grant programs. Applicants should consult the BID for the specific grant program for which they are preparing the appraisal for detailed requirements on number and type of appraisal. Generally, this will be one certified appraisal report, however, properties with very low estimated values may be able to complete a less rigorous analysis. All appraisals must be prepared in accordance with the most recent version of the EEA Specifications for Analytical Narrative Appraisal Reports. The EEA appraisal policy and specifications are available at http://www.mass.gov/eea/docs/eea/dcs/fy15-gr/eea-grant-programs-appraisal-report-requirements.pdf.

To receive funding for an appraisal, the municipality must do one of the following:

a. Apply to the FY22 LAND, PARC, DWSP, or Landscape Partnership grant program, to acquire the property appraised, or, an eligible 501(c)(3) non-profit organization may apply to the Conservation Partnership grant program to acquire the property appraised provided the municipality commits to hold an interest in the subject property.

Note: The PARC grant reserves a portion of its funding for Small Towns (classified for PARC grant purposes as those with 35,000 or fewer residents); applications from such communities will compete only against applications from other PARC-designated Small Towns.

The Property (for which appraisal funding is sought) must:

- a. **Not be permanently protected.** This includes properties not protected under Article 97 either through an EEA grant program, a Conservation Restriction (CR), or Agricultural Preservation Restriction (APR), or other land protected under Article 97. Lands enrolled in Chapter 61, 61A or 61B are eligible to receive funding;
- b. **Not be owned by the municipality/eligible 501(c)(3) non-profit organization.** Appraisals for land already owned by the applicant municipality or a non-profit organization are not eligible for reimbursement; and
- c. **Not be in a designated Priority Development Area**, as shown on the <u>South Coast Rail Corridor Plan</u>, <u>I-495/MetroWest Development Compact Plan</u>, <u>Merrimack Valley Regional Plan</u>, <u>Central Massachusetts Land Use Priority Plan</u>, <u>Metro North Land Use Priority Plan</u>, or other regional plan as they become available (if applicable). See Executive Order No. 525.
- 2. <u>Preparation of an Open Space and Recreation Plan (OSRP):</u> Preparation of an OSRP may include creating a new plan, updating an expired plan, or updating a plan that will expire by June 30, 2021. Consult the <u>OSRP Workbook</u> for details. Contact Melissa Cryan with specific questions about the OSRP process at melissa.cryan@mass.gov.

To receive funding for an OSRP, the municipality must apply to the FY22 LAND, PARC, DWSP, or Landscape Partnership grant program.

3. Preparation of a plan to facilitate a conservation project: Preparation of a plan or plans to facilitate land conservation projects in the applicant town. Plans may include, but are not limited to, mapping of locally-important agricultural or forestry soils, and site assessments to determine the most environmentally important portions of a property that will be the subject of an application to an FY22 EEA grant. Subject to EEA approval. For eligibility of a specific project idea, contact Nathaniel Thomas at nathaniel.thomas1@mass.gov.

B. ELIGIBLE APPLICANTS: This BID is open to Massachusetts municipalities, which must:

- 1. Have a population below 6,000 people. Population will be determined using the 2019 Census estimates provided by the UMass Donahue Institute. A list of eligible communities is attached at Exhibit B.
- 2. To be eligible for funding for appraisals or plans, the municipality must apply for one of the following EEA grants during calendar year 2021 (applications are due from July-December): Act and apply through the conservation commission for all projects in support of LAND and Conservation Partnership grants; through the appropriate town entity for projects in support of a PARC grant application: through the board of water commissioners for projects in support of the DWSP grant: and, through the select board or town administrator for projects in support of planning. Applications in support of a Landscape Partnership grant should be filed by the town entity that will be a partner in the Landscape Partnership grant application.
- 3. Have no unresolved protected open space conversion issues with EEA (see <u>EEA Article 97 Disposition</u> Policy).

C. FUNDING AVAILABILITY, BUDGETING GUIDELINES & ALLOWABLE EXPENDITURES:

This is a reimbursement program. Reimbursements will be based upon submitted proof of municipal expenditure, not to exceed 80% of the approved project cost. Maximum funding available for an appraisal is \$3,000, available in FY21 only. Multiple appraisals for the same property interest will not be funded unless required by an EEA grant program, and must be approved by EEA. Maximum funding for the preparation of an OSRP is \$12,500. Maximum funding for other types of planning is \$5,000, available in FY21 and/or FY22. Expenditures must be contracted with outside vendors; in-kind services or municipal employee wages or salaries will not be reimbursed. **Municipalities must have an executed state contract prior to commencement of work.**

All contracts shall be subject to available funding, whether through the appropriation and authorization of sufficient funds or the receipt of sufficient revenues. If available funding ceases for any reason, a contract shall be deemed under suspension and contract performance must halt. A contractor will not be entitled to compensation for any performance provided during the period of contract suspension. EEA may lift the suspension if available funding is received. In the absence of foreseeable available funding, EEA may terminate the contract.

D. BUDGET REQUIREMENT: Municipalities selected to receive grant funding must show expenditure of municipal funds. They will be required to submit documentation of municipal expenditure for total approved project cost, as shown by canceled municipal checks, wire transfer statements, and/or a statement from the municipal treasurer.

E. PROJECT TERMS:

Expenditures must not predate contract execution

Appraisals will be funded with FY21 contracts and must be completed on or before June 30, 2021. Only work done while under contract and on or before June 30, 2021 will be reimbursed. To receive

reimbursement payment for an appraisal under this BID, an eligible application to acquire interest(s) in the property appraised must be submitted to the FY22 grant round of one of the following EEA grants: LAND, PARC, DWSP, or Landscape Partnership, or must agree to hold an interest in a property that is the subject of an eligible FY22 Conservation Partnership grant application. The application to the other EEA grants must include the appraisal prepared with the use of this grant funding under this BID.

OSRPs will be funded with a contract covering one or two years. Reimbursement payment for an OSRP under this BID is contingent upon receipt by EEA of an eligible application to an EEA grant. For FY21 and FY22 contracts, work allocated for FY21 must be completed on or before June 30, 2021. Work allocated for FY22 must be completed between July 1, 2021 and June 30, 2022. A draft OSRP must be submitted to EEA no later than the application deadline of the EEA grant program to which the municipality or partner non-profit will apply. A draft OSRP may require additional edits to Sections 1-5 after submission, but Sections 6-9 must be final and informed by a thorough public participation process, as described on page 12 of the OSRP Workbook. For contracts only in FY21, a final OSRP must be completed and submitted to EEA for review no later than April 1, 2021. Two-year contracts will receive reimbursement in the first year for work completed through June 30, 2021; however, final reimbursement in the second year will be contingent upon completion and final approval of the OSRP. For specific questions on timing and OSRP requirements, please contact Melissa Cryan at melissa.cryan@mass.gov. This includes questions in regard to the public participation process requirements during the COVID-19 pandemic.

Other planning projects will be funded with a one- or two-year contract, as determined by EEA to be appropriate. Work allocated for FY21 must be completed on or before June 30, 2021. Work allocated for FY22 must be completed between July 1, 2021 and June 30, 2022. The plan must be completed, and any other terms and conditions met, as determined by EEA and described in the scope of the contract, prior to reimbursement.

If awarded, all projects will be required to abide by the Standard Commonwealth of Massachusetts Terms and Conditions. In addition, all final contracts are subject to successful negotiation of a Final Scope of Services. EEA does not guarantee that any contracts may result from this BID or that any particular funding level will be awarded. It is anticipated that projects could commence immediately upon EEA's decision. Contracts may be extended or otherwise amended at the sole discretion of EEA.

- **F. ANTICIPATED DURATION OF CONTRACTS:** All contracts for appraisals only will end on or before June 30, 2021; all contracts for OSRPs and other plans will end on or before June 30, 2021 or June 30, 2022.
- **G. DELIVERABLES, OWNERSHIP, AND CREDIT DUE:** Appraisals funded through this BID must be used to prepare an application to an FY22 LAND, PARC, DWSP, Landscape Partnership, or Conservation Partnership grant. OSRPs must be completed and receive final DCS approval prior to the final OSRP reimbursement payment. Other plans funded through this program must be completed prior to reimbursement.
- **H. REPORTING**: Applicants receiving funding through this grant to prepare an OSRP must submit a draft plan by the application deadline of the EEA grant program to which they plan to apply, or in which they will be a partner. No interim reports are required.
- **I. INVOICING:** This is a reimbursement program. Applicants selected to receive funding will be required to submit a State Standard Contract prior to commencing work. A reimbursement billing form, which will be sent to Applicants with their contract, must be submitted with documentation of payment.

3. Instructions for Application Submission

A. EVALUATION CRITERIA: This is a non-competitive grant; all eligible applications will receive funding on a rolling basis, to the extent that funds are available. Funding is not contingent upon being selected to receive a LAND, PARC, or other EEA grant award. EEA reserves the right to ask clarifying questions on applications prior to making a final award.

B. APPLICATION SUBMISSION INSTRUCTIONS: Applications must be emailed to Nathaniel Thomas at nathaniel.thomas1@mass.gov with a hard copy sent in the mail by **Friday**, **May 7**, **2021.** Earlier submission is strongly encouraged, especially for Applicants seeking funding for an OSRP. Letter from non-profit 501(c)(3) organization eligible for the Conservation Partnership grant, affirming its intention to submit an FY22 grant application, in which the Applicant agrees to hold an interest (if applicable)
Property map (if applicable)

C. DOCUMENTATION REQUIRED UPON APPROVAL FOR FUNDING (to get a contract):

- Commonwealth Standard Contract Form, filled out and signed by the Applicant
- Commonwealth Scope and Budget Form
- Completed Contractor Authorized Signatory Listing (both sides)

D. DOCUMENTATION REQUIRED FOR REIMBURSEMENT:

- **For appraisals:** Copy of appraiser's summary letter/estimation of value (typically the first 1-3 pages of the full appraisal).
- **For OSRP preparation:** Draft OSRP must be submitted by the application deadline for the EEA grant program to which the municipality will apply or be partner to. Completed OSRP submitted to EEA for final approval no later than **April 1, 2021 or June 30, 2022, depending on the timing of the project.** Final OSRP must be approved by EEA.
- **For other types of conservation project planning:** Conditions as determined by EEA at the time of contracting. Planning must be completed prior to submission of a request for reimbursement.

- Receipt by EEA of eligible FY22 LAND, PARC, DWSP, Landscape Partnership or Conservation Partnership grant application, according to the requirements previously described.
- Copy of the bill or invoice from the appraiser, OSRP preparer, and/or plan preparer.
- Copy of the cancelled municipal check(s) paying for the work or a statement by municipal treasurer attesting to payment for the work.

Respondents are encouraged to review the Commonwealth Standard Contract Form, Scope and Budget Form, and Contractor Authorized Signatory Listing prior to submission of an application, available under the Forms & Terms tab of this Commbuys posting, or https://www.macomptroller.org/forms-for-vendors.

C. APPLICATION DUE DATE: Rolling acceptance, not later than Friday, May 7, 2021.

- **D. ESTIMATED AWARD DATE:** Funding selections are estimated to be announced within two weeks of a municipality's submission of a complete application, with contract negotiations to begin immediately thereafter.
- **E. ESTIMATED CONTRACT START DATE:** Rolling. Notwithstanding any verbal representations by the parties, or an earlier start date listed in the Standard Contract Form, and only after an award is issued and a final scope of services has been negotiated, the effective start date of a contract shall be the latest of the following dates: the date the Standard Contract Form has been executed by an authorized signatory of the contractor and the procuring department; the date of secretariat or other approval(s) required by law or regulation; or a later date specified in the Standard Contract Form.

- **B. USE OF THIS PROCUREMENT BY SINGLE OR MULTIPLE DEPARTMENTS:** This BID is a single department procurement. All contracts awarded under this BID will be utilized solely by EEA.
- C. REQUEST FOR SINGLE OR MULTIPLE CONTRACTORS: This BID will result in multiple contracts.
- **D. BID DISTRIBUTION METHOD:** This BID has been distributed electronically using the CommBuys system. It is the responsibility of every Applicant to check CommBuys for any addenda or modifications to a BID to which they intend to respond. The Commonwealth of Massachusetts and its subdivisions accept no liability and will provide no accommodations to Applicants who fail to check for amended BIDs and submit inadequate or incorrect responses.
