
Regeneration Openings Summary

Ware River Forestry proposals for FY-16






Old Turnpike Road proposal

✓ 62 acres

- White pine /oak forest type
- Harvest small groups up to 2 acre (0.5 acre average)
- Some thinning between groups
- Low vigor, poorly formed stems will be targeted
- ✓ Vernal pools present


Route 148 proposal

✓ 92 Acres

dcr Massachusetts

- Mostly WP/oak, with some pure oak stands and some RP along 122
- One up to 5 acre opening in low quality pine adjacent old openings, a few 2 acre openings adjacent to potential heath and RP stand, rest will be small openings 1/3 to 1/2 acre. Aiming for 25 acres total in openings. Some thinning in between groups.
- Targeting low quality declining WP and oak, and whatever RP we can reach



Oak Hill proposal


- ✓ Pine Plains Rd
- ✓ 94 acres
- Mostly WP/hardwood and WP/Hemlock
- Up to three 5 acre openings targeting declining low quality WP stands. Rest will be small openings up to 2 acres in size targeting low quality WP and RM. Some thinning in
 between groups. 5 acres of overstory removal in oak stand in northern portion. Aiming for 30 acres in openings
- One stream crossing to access landing on Pine Plains Rd





Charnock Hill proposal

- ✓ 95 acres
- Mostly Oak/hardwood
- Small openings, 2 acres or less, averaging 0.75 acres targeting areas with less vigor, low quality oak and areas with more overstory RM and diseased beech, and to expand existing opening.
 - Aiming for 20 acres in openings
- Invasive species issues, especially at top of the hill.
- Access issues, will need to improve lower road.
- Vernal pool present






Barre Heath proposal

- ✓ 61 Acres
- Low Quality WP
- Will be clearing 5 acre groups of low quality WP, leaving all PP and most hardwood, to expand rare heath habitat.
- Aiming for 20 acres of opening
- ✓ Working with NHESP
- Hopefully will burn site regularly to maintain heath, reduce buckthorn
- ✓ Vernal Pools present
- Rare Species Habitat Present
