**Purpose:** To distribute to local Workforce Investment Boards, One-Stop Career Center Operators and other local workforce investment partners the Massachusetts FY2011 WIA Title I Annual Performance results.

**Background:** The Workforce Investment Act specifies seventeen core performance measures for Title I programs for adult, dislocated worker and youth services. The expected levels of performance for the state and local areas were established for FY2010 and remained unchanged in FY2011. Please refer to MassWorkforce Issuance #10-61 issued on July 1, 2010.

Annual Performance for Massachusetts and Workforce Areas

Attachment A provides a copy of the Program Year 2010 (FY2011) Annual Report on Adult, Dislocated Worker and Youth Activities that was filed with the U.S. Department of Labor on October 3, 2011. The report presents information on statewide performance relative to the seventeen core performance measures, information on program costs, research and evaluation, use of waivers, and business engagement strategies.

## Annual Career Center Performance Reports

A new *Career Center Performance Reports, Annual Report for Fiscal Year 2011* will be published in November. The annual report will be inclusive of all final program service data and final performance data for the fiscal year ending June 30, 2011. The Annual CCPR will update fourth quarter CCPR data (MassWorkforce Issuance 11-59, issued September 15, 2011) and reflect all customers who were auto exited as of September 30, 2011 and incorporate additional performance related data that was entered in MOSES after June 30, 2011. This new Annual CCPR will combine all fiscal year program and performance data in one publication.
