### Application Training Announcement

The MassDOT Transit Unit is pleased to announce the following training sessions for the MassDOT Community Transit Grant Program for State Fiscal Year (SFY) 2021. The Community Transit Grant Program is the consolidated competitive grant program for Federal Transit Administration Section 5310 Enhanced Mobility of Seniors and Individuals with Disabilities funds and State Mobility Assistance Program funds.

Prior to the application period, MassDOT will host two online trainings. These remote sessions will cover program eligibility and requirements, the online application process, and tips for completing a successful proposal.

The SFY2021 Community Transit Grant Program application period is scheduled to open on **Friday, May 8<sup>th</sup>, 2020** and close at 5:00pm on **Friday, June 26<sup>th</sup>, 2020**. The application will be submitted through the MassDOT Transit Unit's online grants management system, GrantsPlus+. Applicants are encouraged to leave ample time to submit their applications prior to the deadline. Applications received after the deadline will not be considered.
