### **Safety**

Ensuring employee and visitor health and safety remains a priority for the DIA. With the assistance of technology, the DIA continues to provide services through its virtual platform including Conciliations and Office of Education and Vocational Rehabilitation Team Meetings.

In-house investigations continued during the pandemic (March 2020 - August 2021) while field investigations resumed in August 2021.

  - For Fiscal Year 2021, a total of 83 new Section 65 injuries were recorded.
- ★ The WCTF paid \$5,761,538.00 in payments against uninsured claims during FY 2021.
- According to NCCI, COVID-19 Claim Activity
  Nationwide | As of year-end 2020, private carriers
  and state funds reported 45,000 pandemic-related
  claims to NCCI associated with \$260 million in
  case-incurred losses—an average COVID-19 cost
  per claim of approximately \$6,000. Note: This

## <u>Website</u>

Pursuant to M.G.L. c. 152, §65 (4) & (5), the Department of Industrial Accidents (DIA) has established the insured assessment rates to be calculated for all policies **effective July 1, 2021**.

The insured assessment rates for Private Employers are as follows:

- ★ Insured Assessment Rate: 0.0418
- ★ Self-Insured Assessment Rate: 0.0445
- ★ Group S.I. Assessment Rate: 0.0460

For private opt-out, the rates are NA for Insured Assessment Rate, 0.0159 for Self-Insured assessment Rate, and 0.0165 for Group S.I. Assessment Rate








## DIA – Office of Education & Vocational Rehabilitation

OEVR continues to operate in a remote working environment, successfully pivoting in March 2020 with DIAs WebEx platform while still providing vocational services to their clients.



The partnership continues with the Executive Office of Health and Human Services and the Department of Industrial Accidents on the medical reimbursement rate review.


Medical Reimbursement Rate Review

### DIA - Office of Safety

The Department of Industrial Accidents Safety Grant Program **awarded 51 grants** to companies and organizations who were poised to train 4,619 Massachusetts workers in FY 21.

COVID-19 has had a devastating impact and hit small businesses particularly hard. Grant recipients, workers and companies across industries faced a learning curve as they tried to figure out how to adapt to conditions. The Office of Safety worked hard communicating with all companies to accommodate their requests and help them move through the uncertainty. We had many conversations about the viability of their business, the news was not good.

Ultimately, **45%** were able to complete all their training as some companies were able to transition to virtual training depending on the topic. Overall, 50.9% applied for an appropriation to transition all or some of their training budgets to FY'22, this extension will enable companies to have the additional time to complete their training goals.


