One Stop Overview: Brief History

Launched in January of 2021, the One Stop is a **single application portal** and **collaborative review process** designed to **streamline the experience** for the applicant and **better coordinate** economic development programs and staff on engagement and grant making.

The One Stop was created as part of the 2019 Economic Development Plan. Communities voiced **frustration with not knowing about, and the challenges in accessing, state funding resources** to help them advance their goals for economic growth.



The process reoriented the Commonwealth from a passive reviewer of funding requests to an active partner in economic development strategy, priorities, and investment.





- Guidance and Partnerships, allowing applicants to receive key feedback through optional "Expression of Interest" process before completing a full application, and allowing the State to holistically and directly engage with local leadership.
- Ability to be considered for more than one grant program simultaneously, saving time on research and applications to different agencies and programs.
- Greater accessibility to grant programs for small communities with limited staff resources, that would otherwise not have the capacity to prepare applications to multiple grant programs during the year.
- Direct referrals to additional programs to support applicants' priorities that did not fit within One Stop.
- A full view by program staff of community priorities, allowing the state to understand community vision beyond four corners of a single, discrete application.
- **Collaborative review,** allowing for State funding coordination and enhanced State awareness and support for community development goals.

One Stop Overview: The One Stop Process



The goal of the One Stop is to make it easy for municipalities to access our grants, and for the Commonwealth to fund as many impactful economic development projects as possible.

- **Guidance Phase:** Opportunity for applicants to receive guidance on project ideas through the Expression of Interest (EOI), Webinars, and Virtual Office Hours prior to submitting a Full Application.
- Full Application: Designed to guide applicants to apply based on what their projects aims to do within the development lifecycle, on a scale that we call the Development Continuum.
- **Collaborative Review:** Applications are not submitted to specific grant programs, but rather categories that are reviewed by multiple programs that best fit the funding needs of the project.
- Award Decision: The multistep collaborative review results in the recommendation of the most impactful projects across the state.

Past Results



- The first three rounds of the One Stop have resulted in 869 grant awards totaling over \$396.3 million in funding.
- Applications have been submitted by over 760 organizations in 296 different communities.
- Funding through the One Stop is extremely competitive, with demand growing each round.
 - The amount of grant funding requested in FY24 was more than FY22 and FY23 combined.
 - Of all application submitted in the first three rounds, **52% have received funding**.





Regional equity is a key consideration when determining grant awards. In the three One Stop rounds to date, **243 communities across the Commonwealth** have been represented by at least one award.





New in FY25: HousingWorks Infrastructure Program

The HousingWorks Infrastructure Program is now fully integrated into the One Stop!

- HousingWorks Infrastructure Program is a new competitive grant offered by EOHLC to support a variety of infrastructure related activities to unlock housing production.
- The program funds both the pre-development and construction of improvements to publicly-owned infrastructure needed to develop, preserve, or rehabilitate housing in the Commonwealth.
- The program is available to municipal entities, as well as associated public entities (including Public Housing Authorities, Redevelopment Authorities, and Water/Sewer or Service Districts).



The Administration announces the first round HousingWorks Infrastructure Program awards in Revere in October 2023

New in FY25: Improved Expression of Interest

The Expression of Interest has been improved to save applicants time and ensure prompt delivery of feedback:

- **Easier Access:** The EOI Form is now a simple webform accessed directly through the One Stop website.
- Wider Availability: Organizations no longer need to be registered in the IGX system to submit an EOI.
- Multiple Submissions Allowed: There is no longer a limit to the number of EOI forms that can be submitted by an organization.
- **Expedited Feedback Delivery:** The streamlined form reduces the time required for staff to review each EOI, allowing for faster delivery of the Feedback Report.

Additional Notes on the FY25 Round



Streamlined Application Structure

The Full Application has been consolidated into three forms that must be completed by all applicants:

- *Form 1. Applicant Information*: Information about the organization submitting the application.
- Form 2. Project Information: All details related to the project being considered for funding.
- Form 3. Certification: Signature page certifying the authority to submit the application.

MBTA Community Compliance

- Section 3A to the Zoning Act (Chapter 40A of the General Laws) requires each of the 177 MBTA communities to have a zoning district in which multifamily zoning is permitted as of right, and that meets other requirements set forth in the statute.
- Any noncompliant MBTA community is ineligible for funding from the Housing Choice Grant Program, the HousingWorks Infrastructure Program, and/or the MassWorks Infrastructure Program.
 - All other Community One Stop for Growth programs will take noncompliance with Section 3A into consideration when making grant award recommendations.

Development Continuum



- To help guide applicants, the One Stop uses a Development Continuum that describes how a typical economic development project moves from concept to reality within diverse communities.
- All projects submitted through the One Stop will fit within one Development Continuum category.
- This continuum separates economic development activities into two broad categories:
 - Preparing for Growth Grants to support activities and initial steps by community-based actors to attract and guide private investment in a community.
 - Catalyzing Specific Projects Grants to support the private development of commercial, industrial and residential investment projects that further the community vision.

Guidance Phase: Expression of Interest



- The Expression of Interest (EOI) is an optional, short form that gives prospective applicants the opportunity to receive guidance on priority projects before submitting a Full Application.
- After submitting, the prospective applicant will receive an EOI Feedback Report, indicating whether the project is a fit for the funding opportunities through the One Stop.
 - If the project is deemed a fit, the report will indicate the program that best fits the project and tips on how to be competitive for the program.
 - If not, the Feedback Report may include a referral to a state program outside of the One Stop that may be better suited to support the project.

Full Application



- The Full Application opens in conjunction with the January MMA conference. Applicants may begin working on their applications at this time, but can not submit until May.
- Applicants can submit multiple projects for consideration but must submit **one application per project**.
- Following the submission deadline, the **Collaborative** Review process will begin. All applications will then be evaluated based on the following core review criteria:
 - Achievable Project Scope
 - Ability to Execute & Leadership
 - o Achievable Timeline
 - Reasonable Budget, Showing Commitment
 - $\circ~$ Outcomes and Impact
 - Progress to Date, Showing Commitment
- Upon completion of the Collaborative Review, final award decisions will be made. Decision letters are expected to be sent in the Fall of 2024, followed by award announcement events.
- Programs will begin contracting with grantees after award announcements.

- The Project Information form is where the applicant provides all detail related to the project. This form is broken up as follows:
 - **Project Core** The Project Core includes the project information required by all programs in the One Stop (i.e. project scope, budget, anticipated outcomes, etc.).
 - Additional Project Questions Site Preparation, Building, or Infrastructure applicants are required to answer additional questions specific to the type of project being proposed.
 - Housing Choice Additional Questions Eligible applicants seeking consideration by the Housing Choice Grant Program must complete a
 - Other/Optional Attachments An area for applicants to upload any additional attachments, beyond those required in the application.
