

Audit Operations Update

Since the March 2025 Finance & Audit Committee (F&A), Audit Operations (AO) has made progress on

- Audit Planning
- Issue Tracking
- > Formalizing the Audit Policy and Charter
- Piloting a new audit procedures to operationalize the Policy



Audit Plan Progress

The FY26 Audit Plan consists of twenty-seven (27) audits.

AO has rolled the remaining twenty-one (21) FY24 and FY25 audits into the FY26 Audit Plan to focus effort and resources on completing previously planned audits.

We have added six (6) new audits, which are RTA's which reoccur on three-year cycles, as well as our annual CARM audit.

Since our last audit plan report in March of 2025, AO has made the following progress against the audit plans:

- > Nine (9) audits are still in progress, four (4) of which are near completion
- > Two (2) audits have been started
- One (1) audit has been completed
- > Three (3) audits are delayed due to competing outside audits and ongoing software implementations





Since March 1, 2025, AO has added fourteen (14) new audit findings and closed fourteen (14).




Open Audit Issues
