About the Land Conservation Assistance Grant

Program goal: to bolster staff capacity and resources for municipalities and organizations seeking to protect land and develop parks.

- New last year; a few changes for FY26
- Cap of \$60,000 per applicant per fiscal year
- Rolling application deadline (through 4/30/26) and rolling awards
- All grant-funded activities must be completed by June 30, 2026 OR June 30, 2027.

New for FY26

- Applicant must be the entity undertaking the project.
- Staff time is no longer an eligible expense.
- Projects may now span two fiscal years.



Eligible Projects

- a) Assistance **preparing a grant application** for land conservation, acquisition of land for eligible outdoor recreation projects, or park development/renovation. These may be DCS grants **or** other municipal, state, federal, or private grant programs.
- b) Complete some or all of the **steps* involved in land transactions** for the acquisition of a fee interest in land or a CR, Watershed Protection Restriction (WPR), or Agricultural Preservation Restriction (APR).
- c) Prepare or update a municipal **Open Space and Recreation Plan**.

Examples of “steps involved in land transactions”

Due diligence costs

- Appraisals
- Title examination
- Environmental site assessments
- Surveys
- Legal fees associated with the acquisition

Consultant services to assist with negotiation, drafting, or recording of real estate transaction agreements:

- CR or Deed drafting
- Baseline Document Report preparation work



Ineligible expenses

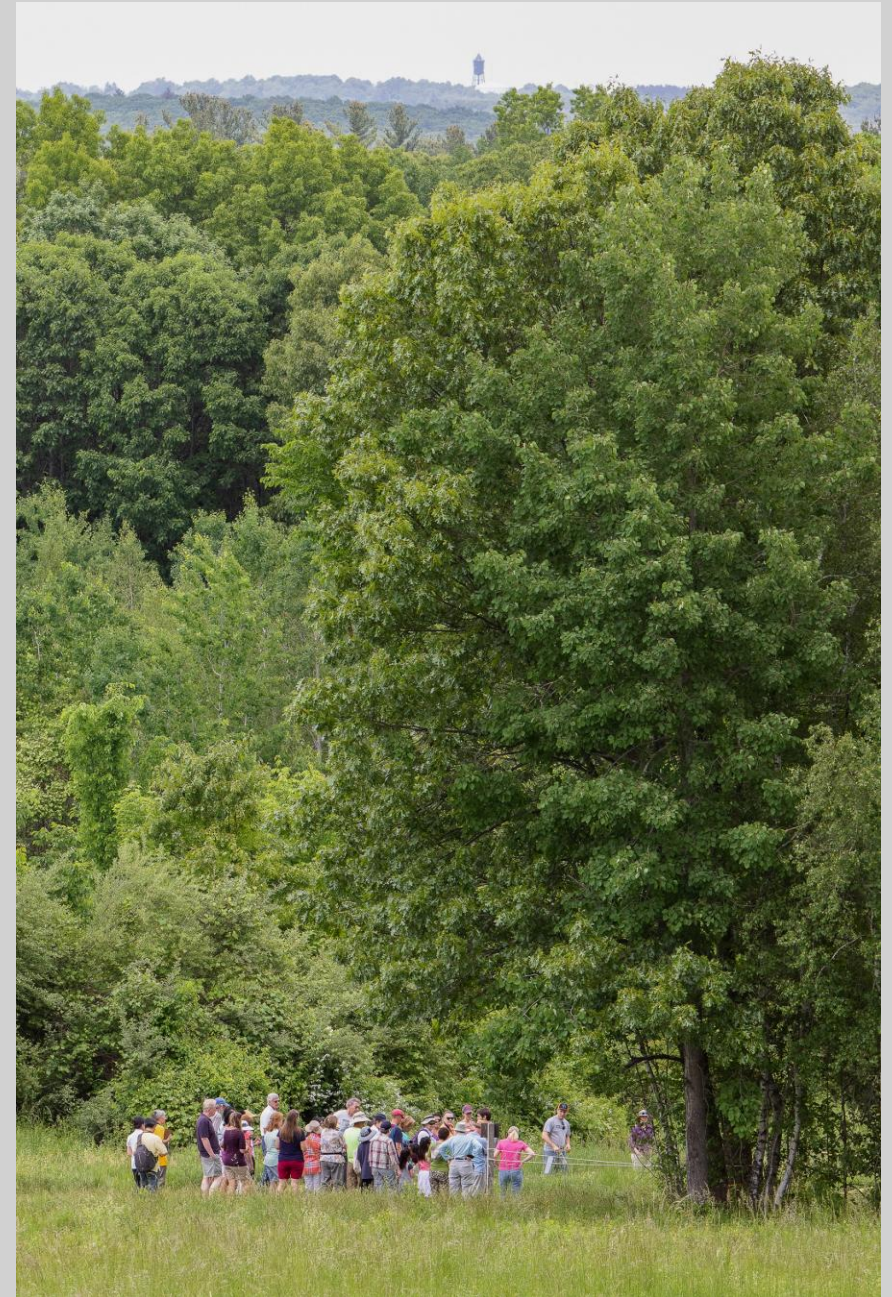
- Property acquisition
- Applicant staff salaries
- Trail construction
- Signage
- Stewardship or monitoring endowments
- Equipment or goods

Some of these *are* eligible under other DCS programs.

This is not a comprehensive list! – ask if you have questions.

Eligible Applicants

- Municipalities
- Land trusts
- Tribal governments
- Conservation districts
- Water or fire districts and other public water suppliers



Match requirement and maximum awards

Reimburses **up to 90%** of project expenses up to:

- \$5,000 for grant writing/preparation; \$5,000 for appraisal (if applicable)
- \$50,000 for other eligible services
- \$25,000 for Open Space and Recreation Plan assistance

May seek funding for multiple projects or services, however, **the maximum award is \$60,000 per applicant.**

Application requirements

- Application form (completed in the online Grants Management System)
- Project budget (use the provided template!)
- Cost estimates/quotes
- Site map (for site-based projects; not required for OSRPs)
- Authorization letter from applicant CEO

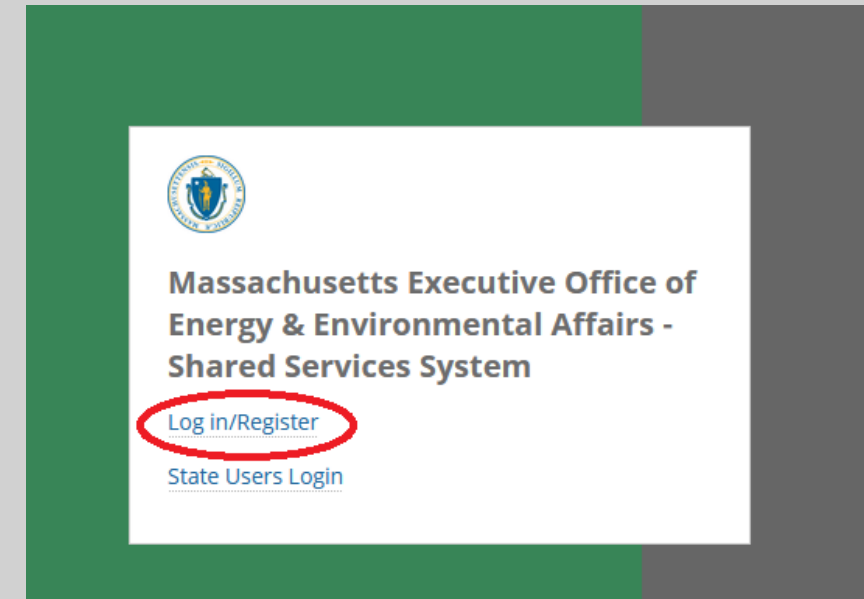

New Grants Management System (GMS)

- Centralizes grants management in one place. Applications are submitted, reviewed, and managed through this system.
- Will soon be used for all EEA grant programs (applicants can browse all grant opportunities).
- Requires that each applicant create an account, which can have multiple users.
- RPAs and consultants may still assist with creating application materials, but the **application must be submitted by a person directly affiliated with the applicant** (staff, board/commission member, etc)

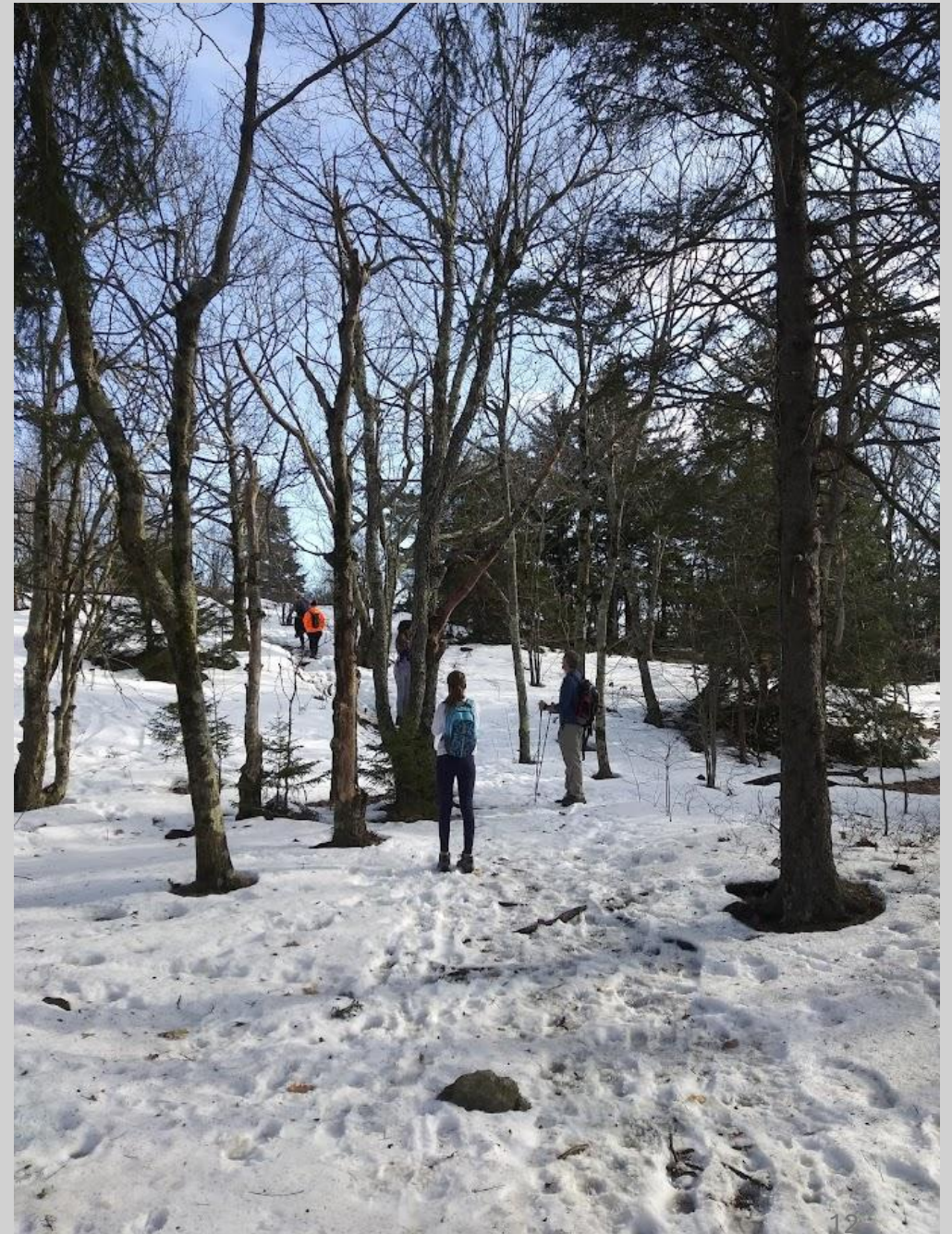

Evaluation Criteria

- **This is a non-competitive grant;** all eligible and approved applications will receive funding.
- Funds will be awarded **on a rolling basis**, as funds remain available.
- If only a portion of listed costs are eligible, EEA may award partial funding.

**Applications will be accepted
through April 30, 2026**
