**NOTICE OF HEARING**

**DOCKET NO. G2019-04**

**Proposed Amendment of Regulation 211 CMR 26.00,  
Annual Financial Reporting for Years Ending 2010 and After**

Pursuant to Massachusetts General Laws Chapter 30A and the authority granted to the Commissioner of Insurance by M.G.L. c. 175, §§ 4 and 25, and M.G.L. c. 176G, § 10, a hearing will be held in Room 1-E at the offices of the Division of Insurance (“Division”), 1000 Washington Street, Boston, MA 02118-6200 on **December 20, 2019 at 2:00 p.m.** The purpose of the hearing is to afford all interested persons an opportunity to provide oral and/or written comment regarding the proposed amendment of regulation 211 CMR 26.00, *Annual Financial Reporting for Years Ending 2010 and After*. The Division proposes to amend 211 CMR 26.00 to include requirements for insurance companies’ internal audit function that will conform the regulation to the NAIC Model Regulation (#205).

This proceeding has been assigned Docket No. G2019-04. Any person who wishes to make an oral statement at the hearing is requested to file a Notice of Intent to Comment with the Division on or before December 18, 2019. All other persons who wish to make oral statements will be heard after those who notify the Division in advance. Written comments may be submitted at any time before the hearing and thereafter until the hearing record is closed.
