Proposed Amendments to 211 CMR 130.00 Credit for Reinsurance

Pursuant to the authority granted to the Commissioner of Insurance ("Commissioner") under G.L. c. 175, § 20A(5)(A) a public hearing will be held on June 17, 2022 at 11:00 a.m. to hear comments on proposed amendments to 211 CMR 130.00, Credit for Reinsurance. The hearing will be held virtually using TEAMS, a digital meeting program. The purpose of these changes to 211 CMR 130.00 is to incorporate the latest revisions to the National Association of Insurance Commissioners Credit for Reinsurance Model Regulation relative to reciprocal jurisdictions. The proposed amendments implement legislative amendments that are codified at G.L. c. 175 § $20A(1)(E^{1/2})$.

This proceeding has been designated as Docket No. G2022-03. Any person requesting to comment orally on the proposed amendments at the virtual hearing must submit to <u>doidocket.mailbox@mass.gov</u> a Notice of Intent to Comment no later than June 15, 2022 at 5:00 p.m. Any person requesting solely to attend the hearing must submit a request to register to <u>doidocket.mailbox@mass.gov</u> no later than 12:00 p.m. on June 16, 2022. All notices or requests must include the person's name, telephone number and email address. An email with instructions for joining the hearing will be sent on the afternoon of June 16, 2022 no later than 5:00 p.m.
