Chair City Inc. (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, July 14, 2015, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Bailey's Report.

- 2. Licensee's Stipulation of Facts;
- 3. Commission's 2015 Compliance Check Guidelines; and

The Commission took Administrative Notice of the Licensee's record.

FACTS

- 1. On Wednesday, May 6, 2015, at approximately 6:40 p.m., Investigators Doyle and Bailey conducted an investigation of the business operation of Chair City Inc.
- 2. While on the licensed premises an underage operative working with investigators purchased from the Licensee an alcoholic beverage, a twenty-four ounce (24 oz.) container of Coors Light beer, for two dollars and seventy-nine cents (\$2.79). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2) — Permitting an illegality on the licensed premises, to wit: c. 138, §34 — Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has had no previous violations, the Commission issues a **WARNING**.
