DECISION

BOB MARTIN'S BAR INC. D/B/A SOUTH GARDNER HOTEL 8 EAST BROADWAY GARDNER, MA 01440 LICENSE#: 00008-HT-0436

HEARD: 6/15/2022

This is an appeal of the action of the City of Gardner Licensing Board (the "Local Board" or "Gardner") in suspending the M.G.L. c. 138, § 12 all alcoholic beverages license of Bob Martin's Bar Inc. d/b/a South Gardner Hotel ("Licensee") located at 8 East Broadway, Gardner, Massachusetts for two (2) days. The Licensee timely appealed the Local Board's decision to the Alcoholic Beverages Control Commission (the "Commission" or "ABCC"), and a hearing was held via Microsoft Teams on Wednesday, June 15, 2022.

FINDINGS OF FACT

- 1. Bob Martin's Bar Inc. d/b/a South Gardner Hotel ("Licensee" or "South Gardner Hotel") operates a business with a principal office located at 8 Broadway, Gardner, Massachusetts. The Licensee holds a § 12 all-alcoholic beverages license which was approved by the Commission on December 26, 1985. (Commission records)
- 2. The Applicant timely appealed the Local Board's decision of January 12, 2022 to the Commission, and subsequently, the Commission issued a Notice of Appeal Hearing dated May 13, 2022, to be held June 15, 2022. (Commission Records)
- 3. On June 14, 2022, Counsel for the City of Gardner submitted a Notice of Waiver to the ABCC wherein Gardner waived its right to contest the appeal by the Licensee and informed the ABCC that it would not be appearing at the hearing on June 15th. (Exhibit A)
- 4. On Wednesday, June 15, 2022, the appeal hearing was held as scheduled.
- 5. The Licensee and his Counsel appeared at the Commission hearing and argued that given the Notice of Waiver along with the fact that the Local Board presented no evidence to

support the finding of a violation, that no violation be found, and no penalty be imposed upon the Licensee.

CONCLUSION

Therefore, the Commission **DISAPPROVES** the action of the City of Gardner Licensing Board in suspending the license of Bob Martin's Bar Inc. d/b/a South Gardner Hotel for two (2) days. The Commission remands the matter to the Local Board with the recommendation that no further action be taken against the licensee as any penalty would be discrepant with this Decision.
