## **Municipal Energy Technical Assistance Grants Available**

The Department of Energy Resources (DOER) Green Communities Division is accepting applications for a new round of **Municipal Energy Technical Assistance** (META) grants.

These grants are for independent third parties that help municipalities, regional school districts, and water/wastewater districts negotiate, develop and manage energy projects, or who perform studies to support the development of such projects. The 2022 round of META grants is available to all Massachusetts municipalities (regardless of Green Community designation status), regional school districts, and water and wastewater districts. The application deadline is **November 18**.

### **Green Communities FY 2022 Annual Reports**

Annual reports are due to DOER by November 4, 2022

The **FY 2022 Green Communities Annual Report** template is available for <u>download</u> <u>here.</u>

Communities should start preparing now by making sure all municipal energy data is in the community's MassEnergyInsight account. This includes making sure all gasoline and diesel consumption is added to the account, as well as checking the "Data Loaded" report in the community's account to ensure all gas and electric utility data has been properly allocated to buildings and facilities.

## **Mass Save Seeks Community Partners**

The Sponsors of Mass Save are seeking partners in organizations and local communities to help Massachusetts families and small businesses located in Environmental Justice communities save money and energy through their programs. Community Partner Teams are eligible for up to \$60,000 in funding annually for two years, as well as in-kind marketing and technical support from Program Sponsors. Municipalities and registered non-profit organizations (or those with a fiscal agent), as well as teams of municipalities and/or registered non-profit organizations are eligible to apply.

The <u>Community First Partnership</u> will support these partners in implementing their energy efficiency residential and small business goals to ensure that all residents have equitable access to the benefits of energy efficiency and decarbonization of energy.

#### **Electric School Bus Assistance Available**

The Massachusetts Clean Energy Center (MassCEC), under the Accelerating Clean Transportation School Bus Program ("ACT School Bus"), recently released the Request for Proposals (RFPs) for the Electric School Bus Deployment Program and the Electric School Bus Advisory Services Program.

For the Deployment Program: MassCEC is specifically seeking applications from school districts as a sole applicant and/or school districts partnered with third-party

school bus fleet operators. MassCEC anticipates selecting three school districts to receive funding and technical assistance for electric school bus fleet implementation projects under this Program. For the Advisory Services Program: MassCEC is offering free technical assistance and planning services for an additional twenty to thirty bus fleets that serve public school districts. Those interested in participating in the Advisory Program, please fill out the Electric School Bus Advisory Program Interest Form. School districts and bus fleets are welcome to apply for both Programs but will not be selected for both. ## **Input Sought on Solar Siting**

DOER is seeking feedback on how to **determine the best locations for future solar projects**. Solar energy will play an important role in achieving our state's clean energy goals, including those established in the <u>Clean Energy and Climate Plan</u> and the <u>2050</u> Decarbonization Roadmap.

There are approximately 3,000-4,000 megawatts of solar in Massachusetts today, and it is estimated that an additional 25,000 to 35,000 megawatts will need to be developed to meet Massachusetts' 2050 Decarbonization Roadmap targets. This translates to roughly 32,000 to 44,000 city blocks or 160,000 to 221,000 acres (for scale, MA has 5 million acres of land).

As DOER considers ways to meet Massachusetts' solar needs, we are interested in hearing from residents about their **preferred types of solar development and land use priorities**. Your feedback will help inform policy makers on what types of solar energy Massachusetts' residents are supportive of so that solar policy can be developed to reflect stakeholder priorities, resulting in a robust solar energy landscape supported by all.
