

**Surcharge**

Gentle Giant maintains a practice of applying a surcharge-to-the-crew for items and moving services of exceptional difficulty.

Surcharge: an additional charge for the moving of pianos, safes, industrial appliances, or anything that falls outside the bounds of normal "household goods" – or, any labor that falls outside normal business hours.

**A surcharge ranges from \$25 - \$100 per Giant.**

Off Hours: Jobs that must start after 4 PM or before 5:30 AM (i.e., at the customer's request) are considered off hours moves and must be surcharged.

- Jobs estimated < 4 hours: \$50 per Giant
- Jobs estimated at 4-6 hours: \$75 per Giant
- Jobs estimated > 6 hours: \$100 per Giant

**SUB-CONTRACTING**

The rates and rules named in this tariff shall not apply to transportation or labor when the Company is acting as Independent Agent, Independent Contractor, or Sub-hauler; when such Transportation/Labor is performed for other Carriers. This exception shall not be construed to exempt from the tariff provisions Carriers for whom the Independent Contractor is performing transportation/labor services.

**LIABILITY**

Gentle Giant Moving Company, the carrier, will provide a limited liability of \$0.60 per pound per article at no additional cost to the shipper. Under Actual Cash Value and Full (Replacement) Value Protection, if you do not declare a higher replacement value prior to

the time of shipment, the value of your goods will be deemed to be equal to \$8.00 multiplied by the weight (in pounds) of the shipment, subject to a minimum valuation for the shipment of \$6,000.

Limit per Vehicle and Terminal Limit:	\$1,000,000
Two or More Vehicles Away from Premises:	\$1,000,000

## **NOTES**

### **Note 1: Definition**

The term "Household Goods, Furniture, and Office Equipment" as used in this tariff means: The transportation of furniture and household goods in whole or in part incident to a move by a householder to or from a dwelling and a storage warehouse, from one dwelling to another, or within a location, and of office equipment or property of a commercial establishment incident to the removal of an establishment in whole or in part from one location to another, or within a location.

### **Note 2: Holidays Observed**

Overtime rates will apply for commercial moves that take place on the following days. Gentle Giant Moving Company may be closed and not operate on some of these days:
