## **DECISION**

QUATRO AMIGOS INC. D/B/A CANCUN'S MEXICAN RESTAURANT 75 WORCESTER ST. GRAFTON, MA 01536

Quatro Amigos Inc. d/b/a Cancun's Mexican Restaurant (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, August 14, 2018, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Keefe's Report.

The following documents are in evidence:

- 1. Investigator Keefe's Compliance Check Field Report; and
- 2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

### **FACTS**

- 1. On Wednesday, May 30, 2018, at approximately 4:50 p.m., Investigators Kujawski and Keefe ("Investigators") investigated the business of Quatro Amigos Inc. d/b/a Cancun's Mexican Restaurant.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a Mike's Hard Lemonade malt beverage, for four dollars cents and twenty-five cents (\$4.25). The underage operative was not asked for identification.

# **CONCLUSION**

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business for over 12 years with no prior violations, the Commission issues a **WARNING**.
