DECISION

**SHREE HARI OM LLC D/B/A GROTON WINE AND SPIRITS
768 BOSTON ROAD

Shree Hari Om LLC d/b/a Groton Wine and Spirits (“Licensee”) holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (“Commission” or “ABCC”) held a hearing on Tuesday, August 5, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Doyle and Quinn’s Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

1. Investigators Doyle and Quinn’s Minimum Purchase Age Compliance Check Field Report, 5/20/25;
2. ABCC Licensing Authority Certification, New License Approved, 10/27/2021;
3. Licensee’s Stipulation of Facts.

There is one (1) audio recording of this hearing.

FINDINGS OF FACT

1. On Tuesday, May 20, 2025, at approximately 6:02 p.m., Investigators Doyle and Quinn (“Investigators”) conducted a compliance check at Shree Hari Om LLC d/b/a Groton Wine and Spirits.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 25 ounce can of Bud Light beer for three dollars and fifty cents (\$3.50). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2021.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a WARNING.
