DECISION

AKSHAR INC. D/B/A HAMILTON CONVENIENCE STORE 178 BAY ROAD HAMILTON, MA 01982 LICENSE#: 0486-00014

VIOLATION DATE: 4/02/2018 HEARING DATE: 5/29/2018

Akshar Inc. d/b/a Hamilton Convenience Store (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, May 29, 2018, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Hooton's Report.

The following documents are in evidence:

- 1. Investigator Hooton's Compliance Check Field Report;
- 2. Licensee's Stipulation of Facts;
- 3. Photo of Underage Operative; and
- 4. Receipt for Alcohol Purchase.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

- 1. On Monday, April 2, 2018, at approximately 3:43 p.m., Investigators Wilichoski and Hooton ("Investigators") investigated the business of Akshar Inc. d/b/a Hamilton Convenience Store.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 6-pack of Bud Light beer, for seven dollars and forty-nine cents (\$7.49). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business for 10 years with no prior violations, the Commission issues a **WARNING**.
