GIO'S PIZZERIA INC. D/B/A GIO'S PIZZERIA 9 ALLEN STREET HAMPDEN, MA 01036 LICENSE#: 0488-00015

Gio's Pizzeria Inc. d/b/a Gio's Pizzeria (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, October 8, 2019, regarding an alleged violation of 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Kujawski's Report.

The following documents are in evidence:

- 1. Investigator Kujawski's Compliance Check Field Report;
- 2. Licensee Stipulation of Fact;
- 3. Receipt for Alcohol Purchase;
- 4. Copy of New License Application Approval 8/3/2015.

FACTS

- 1. On Saturday, July 20, 2019, at approximately 12:21 p.m., Investigators Quinn and Kujawski ("Investigators") investigated the business of Gio's Pizzeria Inc. d/b/a Gio's Pizzeria.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a draft of Bud Light beer for four dollars (\$4.00). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 12 since 2015 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. The Commission issues a **WARNING**.
