DECISION

**HAMPDEN DISCOUNT LIQUORS INC. D/B/A HAMPDEN PACKAGE LIQUORS
7 ALLEN STREET

Hampden Discount Liquors Inc. d/b/a Hampden Package Liquors (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, October 8, 2019, regarding an alleged violation of 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Quinn's Report.

The following documents are in evidence:

1. Investigator Quinn's Compliance Check Field Report;
2. Licensee Stipulation of Fact;
3. Receipt for Alcohol Purchase;
4. Copy of License Transfer Application Approval 10/07/1997.

There is one (1) audio recording of this hearing.

FACTS

1. On Saturday, July 20, 2019, at approximately 12:24 p.m., Investigators Kujawski and Quinn ("Investigators") investigated the business of Hampden Discount Liquors Inc. d/b/a Hampden Package Liquors.
2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a can of Bud Light beer for two dollars and sixty cents (\$2.60). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 15 since 1997 with no prior violations.


CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. The Commission issues a **WARNING**.
