#### DECISION

T STOP MARKET INC. D/B/A T STOP MARKET 1064 MAIN STREET HANSON, MA 02341

T Stop Market Inc. d/b/a T Stop Market ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, September 3, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigators Kenny & Terasconi's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Kenny & Terasconi's Minimum Purchase Age Compliance Check Field Report, 4/8/2024;
- 2. ABCC Licensing Authority Certification, New License Approved 9/8/2023;
- 3. Licensee's Stipulation of Facts.

### FINDINGS OF FACT

- 1. On Monday, April 8, 2024, at approximately 5:18 p.m., Investigators Terasconi and Kenny ("Investigators"), conducted a compliance check at T Stop Market Inc. d/b/a T Stop Market.
- 2. An underage operative, working under the supervision of Investigators, purchased alcoholic beverages, one 6-pack of Bud Light beer, for ten dollars and forty-nine cents (\$10.49). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2023 with no previous violations.

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
