Hunter- Introduced MSP Lt. David Twomey and provided some time for him to introduce himself to the Council. Lt. Twomey will be the HMTC representative and MSP Marine Unit

# **Waiver Exemption Applications**

Hunter introduced Mick Dunning from Sandwich to discuss his background and training status. Mick introduced himself and explained his background. Mick did provide some information that was sent out to the Council prior to the meeting.

Discussion on Mick's training background. Chair went through the list of required initial training requirements and compared Mick's training. BUI Course most likely needed for completion of all requirements.

Bill – Feels comfortable approving Mick for exemption if he completed BUI

Jason – Agrees with Bill, BUI course if offered on a regular basis and should be completed.

Hunter- Do you need the 270 waiver to be processed?

Dunning – No, he will try and get the course completed asap and come back to HMTC

#### **Training Survey Results**

HMTC reviewed the results from the recent training survey. 76 responses from Cape and Islands, South Shore and North Shore. Some may have been reluctant to respond to the survey if they did not have all training completed; tracking was not the intent of the survey.

Bill – Can you see which Departments responded and have needs for training? Would be helpful to reach out to them and see if they are interested specific training to narrow down the demand.

Jason- will check with the Cape Academy, will need some head count to develop costs per student.

MPTC Director Ferullo- Can assist with supporting training; how many do you think and what are the costs?

Hunter – Thank you for support! Many courses we approved used MPTC curriculum and instructors.

Bill – We will have to look for instructors for the Maritime classes listed in the LE portion. We may be able to get this going in short time. Let us review the approved the LE course list.

# **MPTC Acadis**

MPTC Ferullo – update on MPTC Acadis. It is possible to record Harbormaster classes like RIS online Inservice classes. MPTC could assist with recording. Director Ferullo also provided an update on the "bridge academy" for Reserves to upgrade to FT certified status. Director Ferullo explained the possibilities utilizing testing, online classes etc. and will include Harbormasters.

Bill – Timeline for the bridge academy?

MPTC Ferullo – Possibly September/ October. Will need approval from the Civilian Board and will be phased in over a few years depending on the Officers last name.

MPTC Ferullo – offered the group support for special classes of guest speakers. Anyone have any problems or issues to work on? None noted.
