LMS follow up:

Chad Hunter explained that he had been working with Kristin Uiterwyk, UMass Boston the issue is that Kristin and her students have been working with the UMass system and it is not compatible to the MPTC system.

ATON-PATON-this program that Peter DeCola had created works very well and Chad Hunter will see if Peter can help Kristin with that program.

It was agreed by the MHTC that whatever way works best to get us online and up and running the fastest way possible is the way to go. We can rework things as necessary as the program progresses and the funding gets worked out.

Charles Blair and Bob Gillan recommended going for Seaport Council funding.

Training Forms:

Rob Akins and Bill McHugh will collaborate and come up with a form that may be similar to what other agencies use: EP's, & query check forms

Chad will send out the sample forms before the next meeting.

Amendment to 2018 in-service requirements:

MOTION by Chad Hunter to have the In Service requirement be 20 hours of harbormaster CUE's, CPR, 1st aid and remove the ATON PATON or any other online class (for the 2018 requirements)

2nd Charles Blair

Discussion by council all agreed for 2018 until the system is worked out

VOTE: all in favor none opposed

New Business:

MEP training-Rob Akins stated he will bring the EP training requirements to show the MHTC next meeting.

Bob Gillan reiterated that the MHTC should be the ones to produce the State standard for all harbormasters in Massachusetts. Our standards for training should be the equivalent of NASBLA, USCG and EP courses. The council should have 2-3 years of funding and be open to all harbormasters at minimal to no cost to them.

Bob will draft a recommendation for the council for the next meeting and work on the Port Security Grant that has already been approved to investigate by the MHTC.

Chad Hunter will work on several items for the next meeting:

- -Port Security Grant
- -Talk to USCG stations to do regional boat courses.
- -DEP Oil Spill course-Bill McHugh will react out and inquire about those courses

New Business:
