Our records indicate that your company Micro Moves /Harrington Moving has not applied for decals for the year 2001. Department regulations require that a common carrier offering or performing a household goods move within the Commonwealth prove that it has a minimum of \$10,000 cargo insurance in effect for the current year. A decal application is enclosed.

As discussed in my FAX message of May 26, 2000, the official name of your company is Micro Moves. If you wish to change the name to Harrington Moving & Storage, LLC., it will be necessary to attend a hearing at the Department's office at 1 South Station, Boston, MA 02110 to effect the necessary change.

Failure to attend to these matters may well result in a hearing to determine fitness to hold a certificate of public convenience and necessity and ultimate revocation of the certificate. I will expect a reply no later than January 18, 2001.
