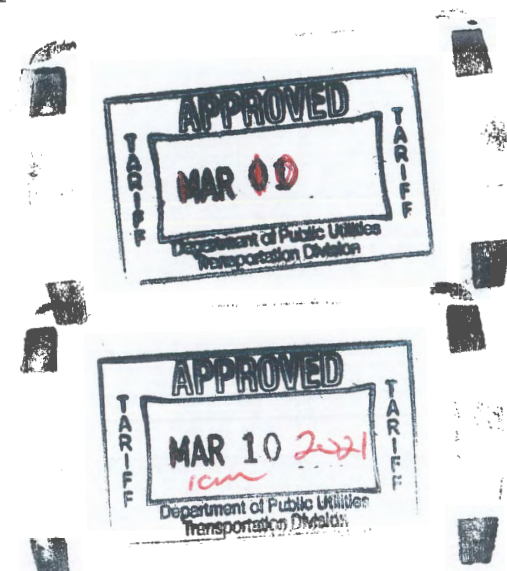

**(C)** Minimums (May 1 – September 1):

1. A minimum charge of three (3) hours per job will apply Mon.-Fri. Travel time is included
2. A minimum charge of five (5) hours per job will apply Saturday, Sunday, Holidays. Travel time is included.

(Sept.2 - April 30):

1. A minimum charge of three (3) hours per job will apply Mon.-Fri. Travel time is included
2. A minimum charge of four (4) hours per job will apply Saturday, Sunday, Holidays. Travel time is included.

Travel Time- Travel time is based on the distance from the moving company headquarters to the first location and returning to the moving company headquarters from the final destination location.

Definition- The term “Household Goods and Furniture” as used in this tariff means: The transportation of furniture and household goods in whole or in part incident to a move by a householder to or from a dwelling and/or a commercial warehouse; or from one dwelling to another.

Estimates/Quotations- Carrier cannot quote a firm price on a move from residence or establishment to another if a public way has to be used by a vehicle. He may give a written estimate, but in doing so be qualified to estimate within twenty-five (25%) of the actual charges. (This rule applies only to travel-time). The final charges assessed shall be in accordance with actual tariff rates.

**(A)**- denotes increase in rate.

**(C)**- denotes no change in rates
