## **FINAL DECISION**

In accordance with the Adjudicatory Proceeding Rules at 310 CMR 1.01(14)(b), Bonnie Heiple, Commissioner of the Massachusetts Department of Environmental Protection (“MassDEP” or “the Department”), has designated me the Final Decision-Maker in this administrative appeal.<sup>1</sup>

I have reviewed and hereby approve the attached Settlement Agreement by Administrative Consent Order with Penalty signed on February 6, 2024, by the Petitioner Gogri Inc.’s representative, Hasmukh Gogri, and on February 29, 2024 by Richard Blanchet, Deputy Division Director of Hazardous Materials Management for the Massachusetts Department of Environmental Protection.

Under the terms of 310 CMR 1.01(8)(c), this proceeding is dismissed with the parties waiving whatever rights they may have to further administrative review before the Massachusetts Department of Environmental Protection as well as any appeal to court.
