



Overview

Beyond Mobility Highlights

- This project addresses replacement of a structurally deficient bridge carrying Bridge Street (SR 125) over the Merrimack River and the Bradford Rail Trail in the following priority areas.
- Primary mobility goal is to replace the existing structurally deficient USMC Private Basiliere Bridge with a bridge with improved bicycle and pedestrian accommodations, supporting **Destination Connectivity**
- Project Investment meets Beyond Mobility priorities for Safety, Reliability, and Travel experience.
- The proposed bridge structure supports system resiliency related to coastal resiliency and climate change attributed to the Merrimack River.

Project Scope

Bridge and Roadway Improvements

Bridge Improvements

- Replacement of the crossing of the Merrimack
 River at the existing bridge location
- Foundation and substructure work including temporary works, subject to TOY restrictions for in water work, and recreational boating and canoe/kayak events
- Separate span for crossing of Bradford Rail Trail at south side

Roadway Improvements

- Defined 4 lane cross-section, 2 northbound, 2 southbound across the bridge
- Separated and protected bike lanes and sidewalks along on both sides of the bridge.
 Complete streets upgrades to adjoining intersections
- Updated Drainage/Lighting
- Stormwater Control Measures
