The Board reviewed submitted materials and discussed Upper Cape Cod Regional Technical School's proposed Post-Secondary Program. Ms. Dorian suggested the Board discuss post-secondary approval requirements at a future meeting.

A MOTION was made by Ms. Dorian, seconded by Ms. Tool, to Approve Upper Cape Cod Regional Technical School's Proposed Post-Secondary Evening Manicuring Program The Chair called for a Roll Call vote: Ms. Viens (Yes), Ms. Talbot (Yes), Ms. Donis (Yes), Ms. Dorian (Yes), Ms. Pearson (Temporarily absent from call), Ms. Saluto (Yes), Ms. Stowe (Temporarily absent from call), and Ms. Tool (Yes). The Motion passed.

North Shore Community College – Using Cosmetology Clinic Space at Essex Regional Vocational Technical High School for Post-Secondary Evening Cosmetology Program.

Karen Hynick, Vice-President of Academic Affairs at North Shore Community College, addressed the Board regarding the College losing its lease on the space for its Adult Ed Cosmetology program. Ms. Hynick requested that the Board permit North Shore Community College to utilize existing cosmetology clinic space at Essex Regional Vocational Technical High School during evening hours to continue its Adult Ed Cosmetology program, when the clinic space is not being used by Essex Regional's Vocational Day program. Members discussed the request.
