## **Health Care Provider Alert**

Beginning on October 1, 2015, all claims and health care transactions between health care payers and health care providers are to include diagnosis codes specified within the International Classification of Diseases, 10<sup>th</sup> Edition (ICD-10) according to federal law. Health care providers are to be aware that claims using ICD-9 diagnosis codes will be rejected and that they must be corrected and resubmitted using appropriate ICD-10 codes.

The Division of Insurance (Division) is aware that Medicare, Medicaid, and most payers have alerted health care providers about this required change, and that many providers are ready to switch to ICD-10 by October 1, 2015. This notice is intended for those who may not yet be ready for ICD-10 to alert them to information about making the necessary conversions.

First, if you use a billing agent to process your claims, you should contact your billing agent to ensure that the agent is ready to use ICD-10 codes on October 1, 2015. If not, you may want to consider switching to one that is ready.

Second, if your office processes all your claims, especially if you submit paper claims to health care payers for payment, it is important to understand the diagnosis codes that are most commonly used by your office. You will want to identify the ICD-10 codes that replace the ICD-9 codes that you regularly use. Keep in mind that while many codes in ICD-9-CM map directly to codes in ICD-10, in some cases, a clinical analysis may be required to determine which code or codes should be selected for your mapping. Always review mapping results before applying them.
