A Design Public Hearing will be held by MassDOT to discuss the proposed Bradford Rail Trail Extension Project in the City of Haverhill, MA.

PURPOSE: The purpose of this hearing is to provide the public with the opportunity to become fully acquainted

with the proposed rail trail corridor project. All views and comments made at the hearing will be

reviewed and considered to the maximum extent possible.

PROPOSAL: The project will extend the Bradford Rail Trail approximately 1100 feet from the Route 125 (Basiliere

Bridge) to Railroad Street. The project will include construction of a 10 foot wide paved path with 2 foot shoulders. The timber decking on a small rail road bridge will be removed and the discontinued access road beneath will be filled in. The existing granite bridge abutment blocks will be repurposed as an overlook feature adjacent to the trail. The project will also include vegetation clearing, signage,

fencing and landscaping.

A secure right-of-way is necessary for this project. Acquisitions in fee and permanent or temporary easements may be required. The City of Haverhill is responsible for acquiring all needed rights in private or public lands. MassDOT's policy concerning land acquisitions will be discussed at this hearing/meeting.

Written views received by MassDOT subsequent to the date of this notice and up to five (5) days prior to the date of the hearing/meeting shall be displayed for public inspection and copying at the time and date listed above. Plans will be on display one-half hour before the hearing begins, with an engineer in attendance to answer questions regarding this project. A project handout will be made available on the MassDOT website listed below.

Written statements and other exhibits in place of, or in addition to, oral statements made at the Public Hearing regarding the proposed undertaking are to be submitted to Patricia A. Leavenworth, P.E., Chief Engineer, MassDOT, 10 Park Plaza, Boston, MA 02116, Attention: Roadway Project Management, Project File No. 608027. Such submissions will also be accepted at the hearing. Mailed statements and exhibits intended for inclusion in the public hearing transcript must be postmarked within ten (10) business days of this Public Hearing. WHAT IS A PUBLIC HEARING?

WHY A PUBLIC HEARING?

To provide an assured method whereby the Commonwealth of Massachusetts can furnish to the public information concerning the State's highway construction proposals, and to afford every interested resident of the area an opportunity to be heard on any proposed project. At the same time, the hearings afford the Commonwealth an additional opportunity to receive information from local sources which would be of value to the State in making its final decisions to what design should be advanced for development.

WHY NOT A VOTE ON HIGHWAY PLANS?

The hearings are not intended to be a popular referendum for the purpose of determining the nature of a proposed improvement by a majority of those present. They do not relieve the duly constituted officials of a State highway department of the necessity for making decisions in State highway matters for which they are charged with full responsibility.

WHAT DOES A PUBLIC HEARING ACCOMPLISH?

It is designed to ensure the opportunity for, or the availability of, a forum to provide factual information which is pertinent to the determination of the final alternative considered by the state to best serve the public interest, and on which improvement projects are proposed to be undertaken.

It is important that the people of the area express their views in regard to the proposal being presented, so that views can be properly recorded in the minutes of the meeting. These minutes will be carefully studied and taken into consideration in the determination of the final design.

RIGHT OF WAY ISSUES

A secure right of way is necessary for this project. Temporary construction easements may be required. Your *municipality* is responsible for acquiring all necessary rights in private or public lands. If your property is affected, your rights are fully protected under law.

1. REASON FOR PROJECT

The completion of this project will serve local needs. The proposed enhancement will also be in the interest of others in the greater community, and provide for the public good.

2. WHO CONTACTS ME?

Representatives of the municipality have already contacted or will contact you. They will explain the procedures used in acquiring any necessary rights in land.

3. WHAT ABOUT DONATIONS? WHAT IS A RIGHT OF ENTRY?

City officials will often seek donations, of parcels, where permanent rights are required. This procedure will minimize the acquisition cost for your community.

A Right of Entry is a document that is signed by the owner. It allows the Contractor to perform certain types of work on the owner's land. The work is usually minor in nature and frequently consists of loaming/seeding behind sidewalks, new driveway apron work, grading/sloping, and wetland protection, etc. The rights granted are temporary in nature.

4. WHAT IS A FAIR PRICE FOR THE ACQUIRED PARCELS?

In the event that donations are not considered, or completed, every effort will be made to ensure that an equitable value is awarded. Municipal and/or outside appraisers will complete an appraisal. Consideration is given to the type of rights needed, whether in fee, permanent or temporary easements. The appraisal will be the basis for arriving at a fair price (for damages that result).

5. MUST I ACCEPT THE MUNICIPALITY OFFER?

No, if the owner feels that the offer is not fair the owner may petition the courts. This action does not stop or delay the acquisition. The action must occur within 3 years. The owner(s) may be paid pro tanto (for the time being). The pro tanto payment will not prejudice the court's final decision.




Figure 1: Locus Map

Bradford Rail Trail Extension Project in Haverhill

PROJECT LOCATION

The project is located along an abandoned railroad right-of-way adjacent to the Merrimack River. The proposed project limits extend from the end of the existing Bradford Rail Trail at Route 125 (Basiliere Bridge) to Railroad Street within the City of Haverhill. The project also includes minor roadway and utility work on adjacent Ferry Street. The total project length is approximately 1,100 feet.

PROPOSED IMPROVEMENTS

The project seeks to extend the existing Bradford Rail Trail from its current termination at Route 125 (Basiliere Bridge) to Railroad Street. The project further improves the safety of bicycle and pedestrian movements in the area. The proposed project consists of constructing a 10-ft wide shared use path with a hot mix asphalt trail surface. The proposed trail head at railroad street will include signs, pavement markings and a wheelchair ramp to meet Railroad Street. The timber decking on a small rail road bridge will be removed and the discontinued access road beneath will be filled in. The existing granite bridge abutment blocks will be repurposed as an overlook feature adjacent to the trail. Some utility replacement/relocation is required as a result of project impacts. The project will also include vegetation clearing, fencing and landscaping.

RIGHT OF WAY IMPACTS

The proposed improvements will require temporary easements from adjacent property owners for construction of the proposed path, side slopes and landscape features. The City of Haverhill is responsible for acquiring all needed rights in private and public lands. MassDOT's policy concerning land acquisition will be discussed at this hearing.

Environmental Impacts

The proposed project is located within a FEMA 100-year flood plain. Efforts will be made to minimize the amount of filling within the flood plain. A potential mitigation site has been identified adjacent to the existing Bradford Rail Trail to compensate for any proposed filling necessary.

Maintenance of Traffic during Construction

It is the intent of this project that all streets remain open to traffic at all times during construction. However, some lane reductions may be required to facilitate the construction process at the trail head and discontinued access road.

PROJECT COST

The preliminary construction cost of this project at this design stage is approximately \$840,000.

PROJECT SCHEDULE

The design plans presented this evening are at the 25% design stage. Design, permitting, and right of way acquisition must be completed by January 12, 2020. Construction is anticipated to begin in the Summer of 2020.
