Called To Order:

- The meeting was called to order at 10:05 a.m. by EA.
- The Executive Director reviewed exit procedures in the case of a fire.

Board Business:

- Review of Minutes:
 - April 19, 2019
LW moved to approve the minutes of the April 19, 2019 meeting as written. SZ seconded the motion. The motion passed unanimously.
- Report from Executive Director, Michael Hawley
Mr. Hawley reported that a new deputy commissioner for boards has been appointed. The new deputy commissioner is Esther Laine.
Mr. Hawley also reported that the agency plans to change applications and renewals to an online only format. The next renewal cycle is in 2021. The renewal notices will be mailed when the time comes but the notices will not contain paper coupons. They will contain instructions on how to renew online. Applications for licensure will also be converting to online only.
Mr. Hawley also reported that, during the next two years the agency will conduct a random audit of Continuing Education for licensees who renewed during the 2019 renewal period.
- Report from Legal Counsel Lynn Read
Attorney Read indicated that all her topics are listed in the Discussion portion of the agenda.

Apprenticeship Extension Request

- **Jeanne D'Amico**- Ms. D'Amico appeared before the board to request an extension of her apprenticeship. This is her first request for an extension. She has taken and failed the IHS

examination once. **LW moved to grant an 18 month extension of Ms. D'Amico's apprenticeship. CC seconded. The motion passed unanimously.**

Application Review

- **Scott Schoen**- The Board received information from Mr. Schoen's apprenticeship sponsor, Beth Levine, regarding his performance within his apprenticeship. However, Mr. Schoen has neither submitted an application for licensure nor has he submitted an apprenticeship extension request. The Board directed staff to take no action regarding this apprentice until either an application or a request is received from him.

Discussion:

- **Over-the-counter Hearing Aid Legislation**- Attorney Read reported that hearing aid industry associations expect that the FDA will publish regulations regarding over-the-counter hearing aid sales in November of 2019. The Regulations will be open for comments at that time.
- **International Hearing Society (IHS) Exam**- Mr. Hawley reported that the IHS exam contract has been signed and renewed consistent with the Board's vote at the April, 2019 meeting that the Board accept the IHS recommended score as the passing score.
