## CONSENT AGREEMENT FOR REPRIMAND

The Massachusetts Board of Registration in Pharmacy ("Board") and Heather Cronin ("Licensee"), a pharmacist licensed by the Board, license number PH22382, do hereby stipulate and agree that the following information shall be entered into and become a permanent part of the Licensee's record maintained by the Board:

- The Licensee acknowledges that the Board opened a Complaint against her Massachusetts pharmacist license related to the conduct set forth in Paragraph 2, identified as Docket Number PHA-2019-0090 ("Complaint").
- The Board and the Licensee acknowledge and agree to the following facts:
  - a. In or about 2018, Licensee worked as a pharmacist at CVS # 17560 in Hanover, Massachusetts.
  - b. On at least one occasion in 2018, while working at CVS # 17560, Licensee accessed a patient's profile for a purpose not related to her job function.
- 3. The Licensee acknowledges that the facts described in Paragraph 2 constitute grounds for disciplinary action by the Board under M.G.L. c. 12, §§ 42A and 61 and under 247 CMR 10.03(1)(v).
- 4. The Licensee agrees that the Board shall impose a REPRIMAND on her license based on the facts admitted in Paragraph 2, effective as of the date on which the Board signs this Agreement ("Effective Date").
- 5. The Board agrees that in return for the Licensee's execution and successful compliance with all the requirements of this Agreement, the Board will not prosecute the Complaint.

- The Licensee understands that she has a right to formal adjudicatory hearing 6. concerning the Complaint and that during said adjudication she would possess the right to confront and cross-examine witnesses, to call witnesses, to present evidence, to testify on her own behalf, to contest the allegations, to present oral argument, to appeal to the courts, and all other rights as set forth in the Massachusetts Administrative Procedures Act, M.G.L. c. 30A, and the Standard Adjudicatory Rules of Practice and Procedure, 801 CMR The Licensee further understands that by executing this Agreement she is knowingly and voluntarily waiving her right to a formal adjudication of the Complaint.
- The Licensee acknowledges that she has been represented by legal counsel in 7. connection with the Complaint and this Agreement.
- The Licensee acknowledges that after the Effective Date, the Agreement 8. constitutes a public record of disciplinary action by the Board subject to the Commonwealth of Massachusetts' Public Records Law, M.G.L. c. 4, § 7. The Board may forward a copy of this Agreement to other licensing boards, law enforcement entities, and other individuals or entities as required or permitted by law.

The Licensee certifies that she has read this Agreement. The Licensee 9. understands and agrees that entering into this Agreement is a voluntary and final act and not subject to reconsideration, appeal or judicial review.
