

NG9-1-1 Refresher Site Visit

The State 911 Department trainers have been visiting PSAPs across the Commonwealth. Updates from our Fiscal Division





Take a minute to review the approved course list on our website so you can rest easy and know that the costs associated with the course may be covered under the Department's Training Grant. The approved course list is updated throughout the year so be sure to review it prior to scheduling classes. PSAPs who conduct in-house training are reminded that these trainings require review and approval each fiscal year.



PSAPs are reminded that all supporting documentation (proof of payment, invoices, course completion) is required with each submission. PSAPs should dig it out and submit it with the reimbursement request to avoid reductions/returns. Please do not double side reimbursement (or application) requests.



As we bounce between fiscal years, please be sure to use the proper fiscal year forms. Both FY 2023 and FY 2024 are available on the website. The Development Grant has additional fiscal year forms available. Please be sure to download the forms for the fiscal year under which you are seeking reimbursement.



We've got you covered! Sign up for our <u>virtual</u> application and/or reimbursement workshops. The application workshop is held on the third Monday of the month and covers the application process for all grants. The reimbursement workshop is hosted on the third Wednesday of the month and the forms, documentation and process for the submission of reimbursements are reviewed. Test Calls Save Lives!

The State 911 Department commends the Town of Ipswich Public Health Department for including a 9-1-1 test call in their inspection process. Inspector Jack Morris recently made a test call from a pool. His first attempt did not come to Massachusetts. After his second attempt, Ipswich Communications reached out to the MLTS compliance team for help. Our investigation determined that the MLTS was not compliant.



Kudos to Jack Morris and the Town of Ipswich.
We encourage all individuals responsible for pool safety inspections to adopt similar policies.

Call Ring Tones

The ring tone for e7-digit and admin calls will be changed during your PSAPs scheduled preventive maintenance (PM).

9-1-1, Text-to-911, and the abandoned call tone are not changing.

This change allows dispatchers to differentiate the call type audibly allowing the primary focus to be on the Response Assist (mapping software).

MLTS Compliance Update

As non-compliant MLTS are identified by PSAPs, the State 911 Department works with MLTS owner/operator through education and testing on 9-1-1 calls.

Updates from MassEDP



Massachusetts Equipment Distribution Program (MassEDP) provides adaptive telephone equipment to people who have difficulty using a landline or wireless telephone due to issues such as hearing loss or vision loss. The telephones that are part of MassEDP can assist with providing a more clear, independent phone communication and the ability to contact 9-1-1 in the event of an emergency. The specialized telephone equipment is offered to people with a permanent disability for little or no cost, depending on income level.
