

**Multi Line Telephone Systems (MLTS) WORKSHOP for Managers, Dispatchers and I.T. Personnel** State 911 Department's Systems Analysts, Joe Hickey and Charlie Ashworth will conduct an on-line presentation and discussion about what Multi Line Telephone Systems (MLTS) are and how they affect location information for 9-1-1 calls that route into our PSAPs. We will also discuss how we are trying to resolve this issue and the assistance that we need from our PSAPs.

#### 9-1-1 Spotlight: Scituate Police Dispatcher Josh Kimball

On Tuesday, July 27, 2021 during a busy shift, Dispatcher Josh Kimball received a 9-1-1 call from a woman in distress reporting that she and her friend were out paddle boarding when they encountered bad weather and lost sight of each other – neither party was wearing a life jacket. Dispatcher Kimball was able to keep the caller calm while gathering critical information under extreme circumstances. Using the caller's mapping location as well as the measuring tool from the NG9-1-1 mapping system, Dispatcher Kimball guided first responders to the caller's exact location where she was rescued from the water and brought to safety. After a continued search, the second paddleboarder was located hanging on to a lobster trap buoy and she too was brought to safety.

Thank you for your outstanding service Dispatcher Kimball. Your quick thinking and familiarity with the NG 9-1-1 mapping system significantly aided in the successful rescue of the two paddleboarders, quite possibly saving their lives.
