 - Harry Mattison: does a lot of running. Greenough-Herter loop is quite nice 5K run where people can gather afterwards and eat and drink. Lots of good information in the original 2002 master plan document that has not yet been implemented. How does this park be both a local and regional park.

- Jane McHale: used to row with community rowing and was coxswain and steered it into embankment and wrecked the boat. Used to take family walks. Played on the incredible trees right by the Herter Center.
- Jessica Robertson: Talked about turtle hatching experience. Baby turtle wanted to curl up in the drum attracted by the vibration.
- Joy Arcolano: Favorite memory August day from 10 AM to 10 PM with 10 little kids. Honk parade, food trucks, lecture, Shakespeare performance. This was an all-day series of events in the park, kids were entertained for a full day. Turtle hatching window is now on her schedule.
- Paula Alexander: Remembered the opening too, big event and such grand plans, she thinks budget cuts stopped things from continuing. You see so much space when you go there, you feel you're out of the city like going into the country – beautiful view of the water.
- **Peggy lafrate**: performances and baby turtles hatching to the music, vibration from music helps with the hatch. "Hatch evening." Favorite memory is from 2019 – oldies band came in; older couple got up and were dancing. End of the evening they came up to Peggy and said, with tears in his eyes said: "you helped us be sixteen again."
- Troy Brogan: they are runners so they love the 5Ks. Their son loves the playground it's one of his favorites. There is a lot this park offers to a lot of people. Owl's Nest pop up has been an interesting use.
- **Bruce Kline**: After falling into the river in 1958 as a member of the crew team and coming up with tar on his feet, to be able to see the bottom and see fish is special.

b. One thing you would like to see changed at Herter Park

- Tim Mc Hale: would like the connections to Mount Auburn Cemetery, MAC, Downtown with water taxi, Soldiers Field Rd become cycle track.
- Aaron Ellison: wishes drainage was better, would love to see more water sheet access points for boating.
- Tony D'Isidoro: BBN get out of the parking lot. (BB&N uses main lot for drop/off & pickup point using shuttle buses), Harvard has high standard of grounds maintenance and security and lighting and so he would hope that same standard would be the goal for Herter Park. Not sure why the amphitheater operation failed - it was going along just fine and then went through a dark period. May be worth understanding why it failed.
- Harry Mattison: connections to Allston-Brighton neighborhood are dismal, need more crossings from the neighborhood, desperate need for safe crossing from Smith Field to Herter Park. Herter is an important connection for people via bike to Boston so need to really make space and deal with bike and ped conflicts on Soldiers Field Rd.
- Jane McHale: Lighting it's an expectation that you don't go down there after dark. Scary place at night. Shoreline along the moat is in great need of repair. Goose poop is nasty. Herter Center/amphitheater was built "high quality arts" accessible to all outside and not just downtown – partnership of arts, stewardship, environmental education

and connection to the community – Herter Ctr Space and Island are keys to this – magic comes from being in this space.

- Jessica Robertson: Coming out of performances, the path and parking lot are very
- **Joy Arcolano**: Mosquitos at moat. Big dream when the Herter Center and Herter Theater were built there was ambition to have this as a performing arts center. How can we have arts, environmental education in an outdoor environment.
- **Paula Alexander**: Need a good maintenance plan to really clean it up. Security and lighting, community garden needs some help and figure out a way to make it look better. Hopes we don't see a lot of high-rise buildings popping up.
- **Peggy lafrate**: long list of improvements because we live in it. The moat is currently a "liability" instead of this special body of water that nobody else has. I would like to see it dredged and an area that is "alive." Make it beautiful. The moat does keep the amphitheater area safe as there is only one entrance.
- **Troy Brogan**: Connectivity, access to water with paddleboard and kayaks to get into water more easily, improved lighting. Safe crossings across the parkway have not been implemented and are long overdue; Redo Soldier's Field Road with traffic calming and multi-modal features.
- **Bruce Kline**: lighting in the park and access to amphitheater, cover over Herter Amphitheater for protection in all weather. Concern about high rise projects along this stretch. Eliot Bridge to kayak rental is almost a marsh, needs better drainage. Area from the boat house to the Arsenal Bridge is a wonderful area for trails, needs to be cleaned up, but that section has great potential. Shoreline maintenance and erosion and causing trees falling into the river.

c. Discussion

- Craig Cashman talked about planned crossings of SFR (Everett St, Telford St & Smith Park) – DCR is scheduled to meet with the City of Boston in the next couple of weeks. We are ready to go with this project. Final project meeting this spring/summer and hopefully the crossing is completed in the fall.
- Harry Mattison reminded DCR there is a commitment to provide two crossings Craig said Rep. Moran has procured \$250K to study connection to Smith Field. DCR is working toward other crossings with Davis Co. with an MOU.
- Tony D'Isidoro indicated that there is also a commitment to a crossing at Smith Park by WBZ group.

3.4 Friends of Herter Park (FOPH): Peggy lafrate

a. Role of FOHP: The Friends have transformed the amphitheater over the last five years. It was underused and neglected before. They have a 3-year MOU with DCR. Friends are the custodians/curators of the amphitheater, they pay for the power, bathrooms, etc. They try to work with others who want to use it when we can, try to accommodate those other uses. All programming is free.

b. What Works:

- The space works for them now, is alive.
- The neighborhood is grateful, they can't believe all programming is free
- Diverse programming: jazz, spoken word, theater, children's programming

c. Challenges

- Entertainment in outdoor weather/elements. Friends are super vigilant about safety cannot have electrical equipment on stage when it's sprinkling, they cancel the event.
- April to Halloween programming
- Have to bring in temporary bathrooms
- No office space, no storage space
- Mosquitoes. They reached to Disney World for ideas they will try garlic oil spray.
- "Bootstrapping it" worries that Live Nation swoops in and then it's another commercial enterprise.

d. Wish List

- What are we doing with the Herter Center? Can we participate in the use of this structure? Maybe have restrooms in there.
- They have zero storage. We have to load/pack everything up and take it away. It would be great to have access to day-to-day storage that is safe and secure.

3.5 Harvard University: Kendyl Maher

- a. Role of Harvard: So many members of our community use the park, including herself for running. Hoping to continue Harvard's commitment to open space.
 - They want to hear how we can work with our neighbors to be the most supportive stakeholder. Looking to put our support behind what is needed.
 - Public Realm Flex Fund for improvements

3.7 Head of the Charles Regatta (HOTC): Fred Schoch, Mason Cox

- a. Role of HOCR: Regatta is in its 58th year this year. 11,000 competitors from world-wide, \$60M in economic impact to the region.
 - Herter Park is the epicenter of the Regatta (moved from Magazine Beach about 12-15 years ago).
 - They did a design study for the Herter Center as their HQ (\$150K investment) they
 are happy to share their study with us. Intended use of the Herter Center: It was going

- to be a shared use facility upstairs Head of the Charles offices; multi-use space on the ground floor.
- \$7M project for Herter Center reno was a "bridge too far for us to tackle". It was going to take a full rehab, mold remediation, new utilities, elevator, would cost lest to build new.
- HOTC currently resides at the Cambridge Boat club.
- 2nd to last full weekend in October is when event is held. They restore the grass after.
- Buildout and breakdown for the event takes about two and a half weeks, managed process.

b. What Works:

- From a big-event perspective, they covet open space above all else. Herter is the last big open space on Charles River, if the Park gets chopped up too much, or there are too many trees, it's not going to work for HOCR but also for people playing frisbee, picnicking etc. (Had to fight a person at some point who wanted to plant 150 trees near Anderson Bridge).
- The large parking lot right now also works for them. They put 70-90 trailers at parking lot # 4 (Artesani); annually they park 120-125 trailers total, so there are other places along Herter that accommodate the rest (e.g., east of the parking lot and near the NU boathouse). If we put landscaping at Artesani "we are done" unless we can close SFR and park the trailers there -they did that one year and Mitt Romney reopened it.

c. Challenges:

- Drainage. It gets really wet there in the fall. They put up a number of tents east of the Herter Center. They've talked about partnering with DCR to raise the level of the land up with 1.5' of gravel underneath to help with drainage. They used to park boat trailers on the large lawn, but the ground is too soggy.
- They've been putting down flooring in areas that they know are soggy.
- Shoreline is eroding. They're committed to shoreline restoration, they think it needs rip rap, massive boulders like a project near MIT. They've collaborated with Weston & Sampson on a project near Anderson Bridge.
- They put in 7 or 8 docks or piers for athletes to get on the water sheet, need this access.

d. Wish List:

- Access to potable water is important currently there's only a drinking fountain at the playground.
- They bring in about 24 generators (12015 at Herter). With respect to sustainability, it would be great to install electrical substations throughout the staging area to reduce reliance on diesel-powered generators.
- Area past Elliot bridge they've used it in the past but not anymore hard to see the water as the vegetation is not cut down; would like to expand there.

3.10 Rep Moran's Office (Jen Migliore)

a. Rep. Mike Moran is really excited about this process. Has been a supporter of this park for a long time.

3.11 Discussion

- a. Jenny Norwood (DCR) wanted more input from all on the Moat.
 - CRC: it is a real habitat for heron, muscrat / ducks but also for mosquitoes. The silted up channel and vegetation catch trash and sediment and make things worse over time.
 - FOHP: The moat creates a controllable environment for rehearsals and performances, with the bridge as the single point of entry. They drive over the bridge in an SUV / pickup truck to prepare for events – everything needs to be loaded, packed and taken away as there is no storage.
 - FOHP: mosquitoes are a real problem, the State did some spraying last year and it seemed to help. They want to try garlic oil spray this year.
 - Rob Adams asked what if there is no moat? FOHP prefers it as a means of controlling access / existing topography in most of the perimeter would help with that. The moat value as a habitat for turtles etc should not be overlooked.

- **b.** Jasmine Howard Program Director of BLS Crew
 - The BLS Crew program is in its 20th year, serving 120 students per year. They've been using the Herter Park "garage" since 2010, as they were priced out of community rowing. They want the program to be accessible to any BLS student regardless of socio-economic background.
 - BLS wants to be viewed as a Stakeholder in this process.
 - The facilities at Herter are inadequate, but they were told they could make no improvements until they have a lease. They've done minor improvements: removed some dead trees.
 - Claims that Legislation was created in 2014 but no lease has been executed with DCAMM and DCR, this despite the Massachusetts State Legislature mandate. She urges DCAM / DCR to execute the lease.
 - What needs improvement: more user-friendly boathouse, access to water, restrooms, bike racks; a huge mosquito problem.
 - o ROB: access to water, public bathrooms, bike racks are at top of list
- c. **Aaron Ellison** Resident at Telford 180 Condos; member of Working Group; also is on advisory group for the former skating club parcel. He took poll of residents at condos: "What do you like /not like the most?"

- Things that people like best are about user experience: being surrounded by open space, near the river.
- Things that need improvement:
 - o More lights at night to increase the safety
 - o Fenced area to have dogs off leash, and otherwise, leash laws to be enforced
 - o More picnic tables
 - o Basketball court or provide a connection to Smith Playground
 - o Drum circles: positive (culturally diverse) and negative (noise) comments
 - o Better crossing at Telford and Everett St.
 - o ROB adds previous comments: Watersheet access and better drainage
- d. Alain Ferry founder of Race Cancer Foundation, former daily user of Herter Park for running or biking (recently moved to Cape Cod). He has helped organize over 100 races on properties along Charles River He is aware of 10 running events starting and ending at
 - Greatest concern: Issues crossing Elliot and Arsenal Bridges. Turns along the paths that are safe if running in one direction but not safe in the other direction. He suggests engaging w/ running event organizations to figure out these turns.
 - Suggests creating marked courses with minimal signage, to avoid informal course markings for every race which are often done with spray paint, leaving behind visual pollution.
 - o ROB: signage is a good idea. Bridge: scope of this project is to figure out how to get there, not coming up with construction documents, but importance of connection
 - o GINNA: Bridges are property of MASSDOT. Improving connections to the bridge are part of the study; the bridges themselves are not, but we have good relationships with MassDOT.
- e. **Alexander Packard** Friends of Brookline High School Rowing.
 - Boston/Cambridge / Charles River thought of as Epicenter for rowing. 12 of the 13 boathouses along Charles River are owned and operated by private organizations; but there is little access for students who go to public schools. Only at Community Rowing, but only for 50-60 students / year.
 - Brookline High school Rowing shares the rowing setup at Herter w/ Boston Latin. The program has 120 students, plus the 120 rowers from BLS they share space without running water, and with no access to public facilities.
 - He believes there's a huge opportunity the Herter Park Master Plan to accommodate a public rowing facility. Not just for BLS and Brookline High, but for all the 15,000 public high school students.
 - o GINNA: Thanks to Alexander and Jasmine. There is no simple DCR project, there are permitting challenges, looking forward to continuing the conversation.

- f. **Bruce Kline** -Working Group member
 - Things that need improvement
 - o From Eliot bridge to boat rental is becoming a marsh
 - o Moat need to get rid of mosquitos, needs a serious clean-up
 - o Parking lots flood frequently with heavy rain need to have better drainage
 - o Greatly supports the HS rowing
 - o Trails between Henderson and Arsenal St. Bridge serious improvements needed; exposed tree roots make the trails dangerous for bikes and peds
 - Likes Artesani playground as is, maybe access to water's edge / wading area into river (w/ lifeguard)
 - Area east of Eliot Bridge could be good spectator area for HOCR
 - Would like to see widening of pathways, to allow bikes, strollers and pedestrians to coexist.
 - Concern: incredible amount of development on other side of road. Density and heights of buildings may turn area into swamp seriously concerned about drainage.
 - o ROB: New development might create better stormwater management.
- g. **Jean Powers** Allston resident, has little kids.
 - Supports BLS on the boathouse issue. States that crew is one of best ways to get college scholarships and should be accessible to public school students.
 - Invasive species: bittersweet, black swallowwort, knotweed, make sure maintenance is part of the plan.
 - o GINNA: Phase 3 includes site management plan. Will coordinate partner with CR Conservancy, create test plots.
 - Advocates for the "Wild" between Henderson and Arsenal St. Bridge. Clean up but keep the area wild as a "backwoods adventure" area.
 - Get Mitch Ryerson to design a playground sculpture. Local artist, world-famous, has an Allston studio but doesn't have a playground in Allston.
 - When talking about nuisance wildlife, beavers have been noted on the Charles in Watertown, it is a matter of time that they will arrive at Herter, let's leave them alone.
- h. **Paul Creighton** Local resident, Working Group member

- He has been going down to river back when it was a trotting horse activity. He remembers when ICA got that building built, they had grandiose plans, tried to work with MDC, ran into money issues.
- Adele Seronde, Christian Herter's daughter, was an arts aficionado she brought such energy to the park in the early 1970s, parties in the evening, day camp. She was able to make lots of things happen using her political connections.
- The park east of Herter Center has been a swamp as long as he can remember, hard to fight nature.
- That moat "has to go". You get eaten alive by mosquitos if you are there in summer when sun goes down "you might as well be on the African Queen." The moat is "the loser."
- The dock where people fish off is "the winner." Develop more fishing opportunities.
- For the Herter Center, combine what goes on with theatre with the vision of Adele Seronde. Connect theater program with the building.
- The area east of Herter Center is full of tremendous activity, feels like a "Parisian impressionist painting".
- Bikes can be very dangerous flying by 40 miles per hour
- Focus on the people that use it, that live around here, for their quiet enjoyment and recreation and not just for the Regatta folks.
- i. Tim McHale Friends of Herter Park
 - Billions of dollars of development happening in the neighborhood. This park is a top priority for the community.
 - Multi-acre "bulge" to the west of Henderson Boathouse "illicit behavior" present maybe change to a big lawn or arboretum. "Dream Big": a pedestrian bridge to connect to Mt. Auburn Cemetery.
 - Would like to see a bike path on the south side of the park for riding for speed.
 - A water taxi park at Artesani parking lot and take a boat downtown.
 - o ROB: opportunity for water sheet / various modes of transportation
- j. **Jen Migliore** Rep. Moran's office
 - Accessibility for High schoolers to rowing: Community Rowing is doing this work.
- **k.** Tom Meier HOCR regatta dock operations volunteer for 14 years
 - Concern about drainage and grading where they normally put mobile docks for HOCR; when it rains it's an "athlete's nightmare" to get from parking lot to the docks.

3.1 Working Group Input

a. Tim McHale:

- Blown away. Amazing work. "I'm very grateful; it's a project 'for the people.""
- Herter Center prefers Alt. 2 (two separated buildings); love the 2nd floor (multipurpose room) and plaza hardscapes, this proposal dignifies HS rowing. He sees the stone circle as a Peace Garden.
- West End Woodland he sees it as an arboretum not a "wild".
- Bikeways along Soldiers Field Road brilliant.
- Connections across Soldiers Field Road:
 - o Why no access from the Speedway to Park. Ginna: Halvorson proposed this, and we are thinking about it, but the retaining walls are going to be there for a long time.
 - o Telford Street Crossing: one idea is to turn Telford into a promenade; half want a bridge and half want an at-grade crossing.
 - At Smith Playground: connection at Smith's dog park, that's where National Development has proposed it

b. Jane McHale:

- Blown away too So many things that are just perfect.
- Community Gardens: loves the joining of the gardens and locating in a less busy place.
- Bike Path along Soldiers Field Road how will cyclists get to the city near Elliot Street bridge? Discussion ensued about crossing at SFR Eliot Bridge intersection.
- Herter Center
 - o Loves the idea of moving the rowing facility there. To expand it to all City of Boston High Schools that want to start rowing is good. Prefers Alt. 2 as well.
 - o As a former rower she knows that crossing of the park path by the rowers will have to be managed by the schools.
 - o Great to earmarking some of the upstairs for Amphitheater use, as well as an events space that can be used by the community.
- West Area of park she likes that it is quiet-ish to balance the eastern area that is more active and dynamic.
- Site Lighting it's a big deal.

c. Jessica Mook:

- Very exciting lots of cool things.
- Road Diet amazing. She likes that bike paths are incorporated on roadway but minimum bike lane is 5 feet, suggests to reproportion the 3' buffer to allow this.
- Herter Center:
 - o How did this use and program come about, and, did we think of anything else? Ginna reply: Commissioner requested HS rowing as there was a site program that needed a facility, and there was a vacant facility than needed a program. Curatorship was looked at as another option, but historically there have not been much interest in Herter Center. We have not talked to any rowing program – wanted to talk to you first. Ruth reply: Boston Latin and Brookline HS are currently inhabiting an area that is not ideal and not properly permitted. They will need a proper space. And we hear from other schools that there is not enough access to the water.
 - o Wants the team to look at the Herter Center more carefully: ideally there will be public access to the building. How much time will the multi-purpose space be available for community use?
 - o Wants us to look carefully at boat conflicts with pedestrians.

d. Aaron Ellison:

- It's a great vision, hopes it does not sit on a shelve.
- Road Diet as a cyclist, he loves the road diet along Soldier's Field road. Opportunities for pedestrian / cyclist conflict are large, however. Likes that there are commuter bike lanes on road but worries about very little buffer between cars and bikes. Rob reply: existing curb line may need to adjust; we tried to hold the existing to see if it works. Clearly having buffered bike lanes is the preferred direction.
- HS Rowing; Prefers Alt. 2. Regarding public boat access.
- Boat access for private boaters / kayakers it's difficult to get your boat on the water and there are no storage options. If you're not using a rowing shell, you're "a third class citizen". Notion of increased public access to get boats in the water would be nice. Rob reply: he is aware of developments that have accommodated public boat storage, perhaps getting developers to include in their program might be a solution.
- Restrooms at Herter Center: he hopes they are four-season. Currently locked from Columbus Day to Memorial Day. Think of the park as a four-season use.
- Access across Soldiers Field Road: community envisions Telford St. as a pedestrian promenade, and visually open / connected to the river.

e. Bruce Kline:

- He has a couple of problems that are hopefully solvable.
- Parking Lots
 - o Every parking space is taken on weekends. How many spots will be lost? Ginna response: there will be no net loss, some parking lots will be expanded.
 - o No way to access the smaller lots if heading East. Currently there's a U-Turn at Elliot Street bridge (Halvorson note: this is not accurate – parking lots will be accessible from both directions as there's no longer a median)

- HS Rowing: He feels torn: likes Alternate 2, but, in terms of direct water access, prefers the layout of Alt. 1 which is easier for unskilled HS rowers to maneuver. Maybe there is a compromise.
- Shared Bike Paths he frequently curses out fast cyclists on pedestrian paths. Separation of cyclists and pedestrians is critical. Ginna reply: its all about creating opportunities for those who want to go fast and those who want to go slow.
- Road Diet consider adjacent developments and the inevitable increases in car activity and number of people.

f. **Jennifer Migliore** (from Rep. Moran's office)

• Site Parking: constituents are concerned that BB&N buses contribute to parking shortage. Jenny reply: DCR is working on a different parking solution with BB&N.

g. Galen Mook

- Chiming in as a resident. Inspired by the great plan but has serious concerns about ongoing development in the area (he is involved in ongoing reviews of developments with the IAG). Are the 1000s new trips being taken into consideration?
- Access across Soldiers Field Road:
 - o Appreciate the fact that there's more porosity from the neighborhood.
 - o 1170 Soldiers Field WBZ / National Development is proposing 700,000 Sq Ft lab; and proposes connection of Smith Field to the river, now being reviewed by the public. Public boat storage is a great suggestion as a community benefit for that enormous project. – this may need to be taken into consideration.
 - o Telford Street crossing wants to maintain an above-grade crossing here because of little kids from the Charlesview development for which this would be a safer
- HS Rowing: concerned about rowers carrying boats crossing a bike path. Small point, but important.

3.1 Stakeholders Input (in chronological order of speakers)

- a. **Alexander Packard** Friends of Brookline Rowing
 - Congratulations on the courage to propose something so transformative. Very exciting to create a community of HS rowing.
- b. **Terry Dougherty** Friends of BLS Crew
 - At BLS crew they like to teach kids not only about the sport but also the importance of the environment.
 - Congrats on restoring the "ties" to the Speedway.
 - HS Rowing: likes the idea of smaller campus (Alt #2). Rowers don't like 90-degree turns.

c. **Tom Martin** – HOCR

- From HOCR perspective at first glance it appears devastating to the ability to run the event (this was corrected by Mason Cox as he saw great potential in the improvements). Difficult to enter Artesani and park the long boat trailers, and the secondary exit which they relied on has been taken out.
- The area where HS Rowing is proposed is their secondary location for trailer parking (in the tree grove). He's very much in favor of HS Rowing but not where it impact HOCR trailer parking.
- HS rowing: boathouse orientation is typically perpendicular to water, Community Rowing has it sideways.
- Don't "underbuild" make sure the HS rowing facility meets present and future needs.

d. **Mason Cox** – HOCR

- Fantastic elements in this plan. Renovated event lawn, relocated community garden, he's extremely excited about the possibilities of these areas that will have better drainage and soils where currently ponding is an issue in the event setup area.
- Rowing facility is stunning and he's blown away. Concept of 7 shells stacked is not realistic for day-to-day rowing operations, there's a limit to how high you can stack, probably 4 is max. Belmont High has a good program, Chris Richards is the contact.
- Parking lot / turning radius is a big issue, trailer access needs to be confirmed.

e. Janet Moonan – CRWA

• Super pleased that we have given so much though to storm water. Did the team look at impervious surface creation as it looks there's quite a bit around proposed HS rowing. (Vesna replied that SFR road diet provides a huge amount of impervious surface reduction so that any new addition will be very much offset by it).

f. **Audrey Richardson** - Friends of BLS Crew

• Incredibly appreciative of the effort to meet their wishes, it seems amazing.

g. **Cynthia Westerman** – BB&N

• Concerned about the impact of Eliot Bridge intersection and any parking reductions. (Ginna replied that DCR's Jeffe Parenti is very comfortable with the proposed SFR road diet and Eliot Bridge intersection, has analyzed the counts and there will be new counts done this fall. There will be no net loss of parking; additionally the bike path and shoulder could be used for emergency / large events.)

h. **Dira Johanif** – CRWA

• Excited and kudos on the plan.

i. **Gretchen Moran Thompson** - Friends of BLS Crew

• She will leave the meeting optimistic and appreciative.

i. **Jasmine Howard** – Friends of BLS Crew

- Absolutely loves the plan, loves the pop-outs to get close to the water.
- The HS boathouse is more than expected. Aesthetically she prefers Alt #2, while Alt #1 is more practical.
- Will grading of areas that are swampy reduce mosquitoes? (Ginna replied that the moat improvements will help).
