2008 Massachusetts Medicare Plan Membership Highlights

Membership

The membership in Medicare Supplement has grown by 341 persons from 2007 to 2008, membership in the Division of Medical Assistance's ("DMA") MassHealth (Medicaid) program has grown by 5,431 persons from 2007 to 2008, membership in DMA's CommonHealth program has decreased by 39 persons from 2007 to 2008, while Medicare Wrap and Medicare Advantage membership has grown by 9,284 from 2007 to 2008.

Medicare Supplement

In 2008, 199,051 Massachusetts residents were enrolled in group and individual Medicare Supplement plans, representing an increase of 341 residents from 2007. In 2008, four (4) carriers (Bankers Life and Casualty Company, Blue Cross and Blue Shield of Massachusetts, Inc., Humana Insurance Company, and United HealthCare Insurance Company through the American Association of Retired Persons) offered Medicare Supplement coverage in the Massachusetts market.

In 2008, 198,996 Massachusetts residents were enrolled in group and individual Medicare Wrap and Medicare Advantage plans, representing an increase of 9,284 residents from 2007.

Public Plans

In 2008, 231,475 Massachusetts residents eligible for Medicare were enrolled in either the DMA's MassHealth Program or CommonHealth Program, representing an increase of 5,431 residents from 2007.

Prescription Drug Coverage

This report provides a breakdown of those Massachusetts residents who are Medicare eligible and have prescription drug coverage in either (1) group and individual Medicare Supplement plans; (2) group and individual Medicare Wrap and Medicare Advantage plans; (3) group and individual Medicare Stand-Alone Prescription Drug Plans; or (4) public programs that include DMA's MassHealth Program and CommonHealth Program and the Executive Office of Elder Affairs' Prescription Advantage Program. In 2008, 930,252 Massachusetts residents eligible for Medicare had unlimited or limited drug coverage, representing an increase of 43,352 residents from 2007. In 2008, 451,514 Massachusetts residents eligible for Medicare had unlimited drug coverage, representing an increase of 6,647 from 2007.
