



# **South Boston Bypass Road** and **HOV Pilot Re-Evaluation**



**Program** 



- I-90 eastbound HOV Unrestricted access to the Ted Williams Tunnel
- I-93 Frontage Road to Richards Street Eastbound 24 Hour Unrestricted Access
- Richard Street/Cypher Street and West Service Road 24 Hour Unrestricted Access
- Westbound (outbound) restriction remain at all times

# **Snow and Ice 2018-2019 Preparation**



- This season all contracted materials spreaders will have GPS devices. Providing MassDOT with real time locations of equipment and enhanced analytics of plow route completion.
- The vendor agreement was posted and distributed to vendors on 8/31/18 (1 year agreement) we have received 90% of the documentation and inspections of equipment has begun.
- All materials contracts are in place, we have started to receive deliveries and forecast to be at 95% of capacity by 12/1/18.
   The salt prices for this season are on average 20% less than last season
- Employee and vendor training sessions have begun and are scheduled to be completed by the first week of December.


## **Major Projects – North Shore**



### **Project Coordination**

- Chelsea Viaduct deck work, although concurrent with the Tobin, will not provide conflicting travel patterns; lanes will be managed to have minimized impact on travelling public.
- Temporary bridge plans are being finalized with the City of Boston for North Washington bridge.
- MassDOT is working with stakeholders on updated communications plans.
- MassDOT will enhance coordination with MBTA to minimize service disruption and communicate with transit users.

## **Regional Impacts**





- Alford Street Bridge will impact the Charlestown Bus Yard
- Tobin Bridge Closures will have operational impacts to the MBTA Bus Route #111
- Additional MBTA Bus operational/routing impacts related to North Washington Street, Alford Street and North Point Mitigation
- Northbound from Boston
- Southbound to Boston


Active Construction with Track/Lane Impacts - 24 hours

## Alford Street Bridge Deck Repair



#### Project Scope

 Replacement of riveted grid deck panels with welded grid deck panels

#### Contract

- \$15 million
- Contractor: SPS New England
- City of Boston design plans and specifications

#### Timeline

- October 1, 2018 through April 30, 2019
- Working 24 hours a day 7 days a week

#### Impacts

Reduced to one lane in each direction





## **Tobin Bridge Deck Repairs**




#### Project Scope

- Concrete deck and substructure steel repairs for upper and lower deck of Tobin Chelsea Approach Spans
- Repair and resurfacing of Beacon Street, Everett Avenue, and 4th Street Ramps
- Repairs to fire protection system

#### Contract

- \$42M project, Contractor: JF White
- Anticipated construction timetable:
   Spring 2018 through end of 2020
- Single lane reduction on lower deck from April through November, each year, beginning in 2019



## **Tobin Bridge – Lane Closure**



- 2018 Lower Deck US 1 NB
  - Everett Avenue On-Ramp Completed in June 2018
  - Beacon Street Off-Ramp Closure August 27, 2018 to end of October 2018
  - Lower Deck Temporary off-peak single lane closures 6:00AM to 2:00PM.
- 2019 Lower Deck US 1 NB
  - Right lane closure from April 1st to August 14th
  - 4th Street Off-Ramp closure Summer 2019
  - Middle lane closure from August 15th to November 30th.
- 2020 Lower Deck US 1 NB
  - Middle lane closure from April 1st to June 27th
  - Left lane closure from June 28th to November 30th
- 2018 thru 2020 Upper Deck US 1 SB
  - Temporary off-peak Single Lane closures 11:30AM to 5:00AM
  - Off peak Night 2 lanes Closure 11:00PM to 5:00AM

## North Washington Street Bridge




#### Project Scope

- Full replacement of structurally deficient bridge
- Improved multi-modal structure providing enhanced mobility for all road users
- Dedicated Bus Lane in to Boston

#### Contract

- \$176M project, Contractor: JF White
- Anticipated construction timetable:
   Fall 2018 through late 2023
- Current configuration on existing bridge - 2 lanes in 2 lane out
- Lanes will be reduced to 2 lanes in and 1 lane out throughout construction



### Chelsea Viaduct - Route 1





- Advertised in July 2018
- Low bid came in at \$169M from Skanska McCourt
- NTP expected in January 2019
- Scope:
  - Substructure repair and retrofit
  - Superstructure replacement with prefabricated bridge units and isolated superstructure repair
- Schedule:
  - Winter 2019 Spring 2020:
     Substructure work
  - Spring 2020 Fall 2020:
     Superstructure work
