RULES AND REGULATIONS

RULE NO. 10 TIME RULE

Time is computed from the time the vehicle and helpers leave the carrier's terminal, until the vehicle and helpers return to the carrier's terminal, less time spent for meals and vehicle breakdowns.

RULE NO. 15 MIXED SHIPMENTS

Rates and Charges in this Tariff apply on straight or mixed shipments

RULE NO. 20 PICK-UP AND DELIVERY SERVICE

Rates in this Tariff include Pick-up and Delivery Service.

"Pick-Up" service refers to the service of the carrier in calling for and receiving of freight and issuing receipts therefor at shipping platforms, doorways, and any other place designated by the consignor, when shipment is directly accessible to trucks.

"Delivery" service refers to the service of the carrier in delivering freight and taking receipts therefor at any platform, doorway, and any other place designated by the consignee, when directly accessible to trucks.

Nothing in this Tariff shall require the carrier to collect and/or deliver freight at places where it is impracticable or unsafe to operate vehicles. Pick-up and Delivery service will be performed within the limits of all cities, towns, villages, to or between which rates apply.

RULE NO. 25 ESTIMATES/QUOTATIONS

Carrier may give an estimate cost, but in doing so be qualified to estimate within twenty-five percent (25%) of actual charges. The final charges to be assessed shall be in accordance with actual tariff rates.

Upon request, the carrier will provide a binding estimate for transportation and other services pertaining to a shipment.
