**DECISION**

**THREE SQUARES A DAY, INC. D/B/A THE SQUARE CAFÉ**  
**150 NORTH STREET**  
**HINGHAM, MA 02043**

**HEARD: 8/13/2019**

Three Squares A Day, Inc. d/b/a The Square Café (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, September 3, 2019, regarding an alleged violation of 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Smith's Report.

The following documents are in evidence:

1. Investigator Smith's Compliance Check Field Report;
2. Licensee Stipulation of Fact; and
3. Copy of Applications Approved 10/9/2001 and 1/7/2003.

There is one (1) audio recording of this hearing.

**FACTS**


1. On Saturday, July 20, 2019, at approximately 3:26 p.m., Investigators Temple and Smith ("Investigators") investigated the business of Three Squares A Day, Inc. d/b/a The Square Café.
2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a bottle of Bud Light beer for five dollars (\$5.00). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 12 since 2001 with no prior violations.

### CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21). The Commission issues a **WARNING**.
