



Description of Admissions Fact Sheet - Hispanic Admissions FY 2017



This annual report provides information on Hispanic admissions to BSAS funded and/or licensed services. In FY 2017, there were 15,565 admissions where the client reported being Hispanic at the time of admission. Starting in FY 2017, this fact sheet includes all age groups (including <18 years of age). To ensure proper interpretation of this data, please read the footnotes and refer to the appendix at the end of this report.

Characteristics of Admissions

- The average age at admission for Hispanic admissions was 36.7 years.
- 25.1% had children under six years of age; 43.2% had children 6-18 years old.
- 5.5% lived with children under six years of age; 9.4% lived with children 6-18 years old.

Appendix

General Notes

- To protect client confidentiality, the data in cells containing 5 or fewer counts are suppressed.
- Data includes primary clients only; a primary client is defined as a person seeking treatment for their personal substance use problem(s).
- Missing/unknown/not applicable responses are excluded from the data. Therefore, the number of admissions for each category/table may vary from the total number of admissions.
- In 2014, a new system of reporting was adopted by some Methadone treatment providers. Due to this system change, the reported enrollment numbers for FY 2014 may be higher than the actual number of enrollments. This also influences any assessment data captured in the trend tables starting from 2014 onward.
- Homelessness at enrollment is determined based on the client's housing disposition at the time of enrollment.
- Due to data updates and changes to definitions, data included in this fact sheet **should not be compared** to similar data published in prior years.
- Data and definitions used were as of *July 6, 2018*.
