Online Insurance Archive Search Instructions

The Department of Industrial Accidents (DIA) has converted the insurance coverage information that were previously available on microfilm to a digital format. The new digital format will be accessible through the DIA website via **DIA Insurance Archive portal**. The information contained in these records dates from approximately 1940 through 1986. For matters after 1986, the DIA's Case Management System would have the insurer of record for all compensable injuries that were reported to the agency.

The search tips below are designed to assist with navigating the new portal.

Search Tips- Required Fields:

- Employer's name is required.
- Search variations of a particular name may be necessary to obtain a match. For example, a company named John Sullivan and Sons, may appear as J Sullivan and Sons or J Sullivan & Sons or John Sullivan & Sons, etc.
- Policy begin and end dates must be in this format 06/01/1979.
- If the date range is not available, enter the company name or partial company name. The system will search for all records containing that string automatically.
