## **FINAL DECISION**

Martin Suuberg, the Commissioner of the Massachusetts Department of Environmental Protection ("MassDEP" or "the Department"), has designated me as the Final Decision Maker in this appeal.

These are waterways appeals, filed on August 16, 2019. The appeals challenged the Department's Jurisdictional Determination for a project proposed by Hither Creek Boatyard d/b/a Madaket Marine ("the Owner"). The Department found that the project was subject to c. 91 jurisdiction but did not require a c. 91 license. Instead, the Department determined that the Owner's project could be authorized through a permit issued by the Nantucket Harbormaster pursuant to §10A of c.91. In a Status report filed on October 4, 2019, the Owner stated that she had decided to terminate the permitting and appeals of her project. On October 7, 2019, the Petitioners filed Withdrawals of their Notices of Claim, with prejudice.

The Petitioners' voluntary withdrawal of their appeals constitutes a waiver by the Petitioners to any further administrative review before the Department as well as appeal to court of the Jurisdictional Determination that was at issue in this appeal. Accordingly, the Department issues this Final Decision incorporating the Petitioners' voluntary withdrawal and dismisses these appeals.
