FINAL DECISION

I am the Final Decision-Maker in this administrative appeal ("appeal") by special designation.

On August 31, 2021 the Massachusetts Department of Environmental Protection ("MassDEP" or "the Department") issued a \$500 Reporting Penalty Assessment Notice ("RPAN") to Holden Oil Mobile Station for failure to timely submit a Third Party Inspection Return to Compliance Completion Report, in violation of 310 CMR 80.49(7)(c)3.f. On October 26, 2021 the Department received the RPAN fee of \$500 from the petitioner Holden Oil Mobile Station. As a result of the Petitioner's payment of the penalty the Parties have submitted a Joint Stipulation of Dismissal requesting dismissal of this appeal as moot. The Joint Stipulation of Dismissal constitutes a waiver by the petitioner to any further administrative review before the Department as well as appeal to court of the RPAN issued by the Department of Environmental Protection. Accordingly, the Department issues this Final Decision incorporating the Joint Stipulation of Dismissal, and dismisses this appeal as moot.
