# DECISION

### 5 PHAN LLC D/B/A KYOTO OF HOLDEN 695 MAIN STREET HOLDEN, MA 01520 LICENSE#: 00032-RS-0534 VIOLATION DATE: 5/24/2022 HEARD: 8/02/2022

5 Phan LLC d/b/a Kyoto of Holden ("Licensee") holds an alcohol l license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, August 2 2022, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Kujawski's Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigator Kujawski's Compliance Check Field Report;
- 2. ABCC Form 43, New License Approval, 9/8/2014;
- 3. Licensee's Stipulation of Facts.

## **FINDINGS OF FACT**

- 1. On Tuesday, May 24, 2022, at approximately 6:44 p.m., Investigators Gould and Kujawski ("Investigators"), inspected the business operation of 5 Phan LLC d/b/a Kyoto of Holden.
- 2. An underage operative, working with Investigators, purchased an alcoholic beverage, one bottle of Bud Light beer for four dollars and fifty-two cents (\$4.52). The underage operative was not asked for identification.
- 3. Mr. Thien Phan, Licensee, appeared at the Commission hearing. Mr. Phan testified he held a meeting with all employees regarding the importance of ensuring they only serve those patrons who are over 21 years old.

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a WARNING.
