DECISION

HOLDEN FUEL, INC. 1175 MAIN STREET HOLDEN, MA 01520 LICENSE#: 00018-PK-0534 VIOLATION DATE: 5/24/2022 HEARD: 8/02/2022

Holden Fuel Inc. ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, August 2, 2022, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Kujawski's Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigator Kujawski's Compliance Check Field Report;
- 2. ABCC Form 43, Transfer of License Approval, 1/26/2012;
- 3. Licensee's Stipulation of Facts.

FINDINGS OF FACT

- 1. On Tuesday, May 24, 2022, at approximately 6:36 p.m., Investigators Gould and Kujawski ("Investigators"), inspected the business operation of Holden Fuel Inc.
- 2. An underage operative, working with Investigators, purchased an alcoholic beverage, one can of Bud Light beer, for two dollars and twenty-four cents (\$2.24). The underage operative was not asked for identification.
- 3. Carlos Elkoury, Manager, and Richard Davenport, General Manager, appeared at the Commission hearing on behalf of the Licensee. The Licensee took steps to ensure all employees received TIPS certification.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a WARNING.
